#### ORDER:-

The Government, after careful examination, accord administrative and financial sanction for a sum of Rs. 19,99,71,210/-(Rupees Nineteen Crores Ninety Nine Lakhs Seventy One Thousand Two Hundred and Ten only) as non-recurring expenditure (i.e Rs. 19,53,05,000/- towards infrastructural facilities and Rs. 46,66,210/- for purchase of equipment) and Rs.3,44,53,440/- (Rupees Three Crores Forty Four Lakhs Fifty Three Thousand Four Hundred and Forty only) as recurring expenditure towards creation of 44 posts, to Government Thoothukudi Medical College, Thoothukudi as detailed in the annexure to this order.

Pending approval of the legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. Orders for sanction of advance from the Contingency Fund will be issued by Finance (BG-I) Department. The Director of Medical Education / Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Director of Medical Education / Chief Engineer (Buildings) are directed to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-2015 to Government in Finance (BG-I) Department at the appropriate time without fail.
- 5. The Director of Medical Education is directed that the amount sanctioned for equipments shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited:-

"K Deposits and Advances (b) Deposits not bearing interest – 8443 00 – Civil Deposits – 800 Other Deposits – CE Deposits of Tamil Nadu Medical Services Corporation Limited (TNMSC) (DPC 8443 – 00 – 800 – CE – 00 OH (Receipts)".

The Director of Medical Education is authorised to draw and deposit the amount sanctioned in para 3 above to the Personal Deposit Account of the Tamil Nadu Medical Services Corporation Limited, Chennai by means of Cheque/Demand Draft in favour of Personal Deposit Account of the Managing Director, Tamil Nadu Medical Services Corporation Limited.
