ORDER:

In the Government Orders first to fifth read above, orders were issued for creation of certain new posts among others in the category of Junior Assistant, Steno-Typist Grade III, Store Keeper and Store-Keeper-cum-Clerk on consolidated pay / outsource basis in the Government Medical Colleges/Institutions viz. Kanniyakumari Government Medical College, Asaripallam, Tirunelveli Government Medical College, Tirunelveli, Thoothukudi Government Medical College, Thoothukudi, Government Vellore Medical College, Vellore, Government General Hospital, Chennai. The details are as follows:

- 2. In the Government Order sixth read above, sanction was accorded among others to bring the certain temporary posts which were sanctioned in the Government Orders first to fifth read above on consolidated pay and on outsource basis to the above said Medical Colleges into regular time scale of pay with effect from 01.04.2007 for the period of one year. This includes the entry level posts such as Junior Assistant, Steno-Typist Grade III, Store Keeper and Store Keeper-cum-Clerk under Tamil Nadu Ministerial Service.
- 3. In her letter seventh read above, the Director of Medical Education has stated that the posts were created to meet out the norms of the Medical Council of India, New Delhi and were filled up by the appointing authorities concerned, on consolidated pay/outsourcing through Employment Exchange by following the rule of reservation, etc. The individuals are working continuously in the said Government Medical Colleges / Institutions till date. The posts created as said above and the personnel are continuously needed for the function of the Medical Institutions and has requested the Government to regularize the services of 166 candidates with effect from 01.04.2007.
- 4. The Government have proposed to accept the proposal of the Director of Medical Education and decided to regularise the services of 166 candidates who have been appointed on consolidated pay and subsequently brought into time scale of pay. As required under the rules, the Tamil Nadu Public Service Commission was consulted for regularising the services of the individuals. In their letter tenth read above, the Tamil Nadu Public Service Commission has requested the Government to frame the service rules for the post of 'Store Keeper-cum-Clerk' and to bring that post under the purview of the Commission.

5. The Government have examined the request of the Tamil Nadu Public Service Commission and found that if the request of the Tamil Nadu Public Service Commission is accepted, it will take some more time to frame the service rules for the said post. Further, the candidates are working in the said post for the past 8 years without getting any service benefits. Further, while issuing orders for creation of 769 permanent posts of various categories to Government Sivagangai Medical College, Sivagangai in the Government Order eighth read above, among others the post of Store Keeper-cum-Clerk has been sanctioned in the name of Junior Assistant in the time scale of pay. Further, the Store Keeper-cum-Clerk post has been shown as identical to Junior Assistant as these posts (Store-Keeper, Store Keeper-cum-Clerk) are carrying the identical scale of pay, the same qualification and the nature of work are all similar to the post of Junior Assistant. Likewise, the nomenclature of the post of Store Keeper-cum-Clerk sanctioned to the above said five Medical Colleges shall be changed as Junior Assistant (Store keeper-cum-Clerk) instead of framing separate rules as suggested by the Tamil Nadu Public Service Commission and therefore, decided to issue an amendment to the Government Order sixth read above that the nomenclature for the post of "Store keeper-Cum-Clerk" shall be redesignated as "Junior Assistant" (Store Keeper/ Store Keeper-cum-Clerk). Accordingly, the Government do and hereby direct that the following amendment be issued to G.O.(Ms) No.144, Health and Family Welfare Department, dated 30.04.2007 changing the nomenclature of the post of Store Keeper and Store Keeper-cum-Clerk.

Amendment

"The nomenclature of the post of Store Keeper and Store Keeper-cum-Clerk wherever occurs in G.O.(Ms) No.144, Health and Family Welfare Department, dated 30.04.2007 shall be re-designated as Junior Assistant (Store Keeper/Store-Keeper-cum-Clerk)".
