### **ORDER :**

The Director of Medical Education in his letter read above has sent the proposal for renewal of 26 Passenger cum Bed Lift in Thiruvarur Medical College Hospital at Thiruvarur for sum of Rs.34.10 lakh for the year 2019-2020. He has stated that the present 26 Passenger cum Bed Lift had been erected during June 2011 and special repairs were carried out during June 2015. He has justified that in the present lift, Automatic Telescopic Landing Door Mechanism complete set including Landing Door Stainless Steel Panel with entrance frame, Automatic Telescopic Car Door Mechanism complete set including car door Stainless Steel Panel and other accessories are completely damaged. It is beyond economical repair and also irreparable. He has also stated that Renewal of 26 Passenger cum Bed Lift in Government Thiruvarur Medical College Hospital is very essential and useful for Operation Theatres and Intensive Care units to the patients and the public.

2. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Work Department, Trichy Region and requested the Government to accord administrative and financial sanction for a sum of Rs.34.10 lakh for the year 2019-2020 for Renewal of 26 Passenger cum Bed Lift in Government Thiruvarur Medical College Hospital, Thiruvarur.

3. The Government have carefully examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, the Government accord financial sanction of Rs.32,55,000/- (Rupees Thirty two lakh and fifty five thousand only) for renewal of 26 Passenger cum Bed Lift in Government Thiruvarur Medical College Hospital at Thiruvarur.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account (Demand No.39 02):-

“4210 – Capital Outlay on Medical and Public Health – 01 – Urban Health Services – 110 – Hospitals and Dispensaries (including Pharmacy) – State's Expenditure – JA – Buildings – 416. Major Works – 01 Major Works”.

5. The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimates for the year 2019-2020 and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department, directly in Form A appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from Contingency fund will be issued from to Finance (BG-I) Department, for sanctioning the advance for required quantum. The Chief Engineer (Buildings) is also directed to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2019-2020 to Finance (BG-I) Department at the appropriate time without fail.

6. This order issues with the concurrence of Finance Department, vide its U.O. No. 35109/Health-II/2019, dated 02.08.2019 and ASL No.908 (Nine hundred and eight).
