ORDER:

In the Government Order first read above, the Government have permitted the Director of Medical Education to fill up Clinical and Non-Clinical teaching posts as per the procedures laid down in Government Order second read above.

- 2. Dr. Suma Abraham has been appointed as Assistant Professor of Anatomy in Vellore Medical College Hospital, Vellore on contract basis with the consolidated pay of Rs. 20,000/- and she had joined duty on 25.08.2005. Subsequently her contract has been extended upto 24.05.2014. Her salary has been enhanced from Rs. 20,000/- to Rs.35,000/- with effect from 17.07.2012 as per Government Order third read above.
- 3. The Director of Medical Education has further stated that salary has not been claimed by Dr. Suma Abraham for the period from January 2014 to May 2014. Therefore she has requested the Government to sanction a sum of Rs.1,67,097/towards the consolidated pay of Dr. Suma Abraham for the period from January 2014, to 25.05,2014.
- 4. The Government after careful examination of the proposal of Director of Medical Education accord sanction for a sum of Rs.1,67,097/- (Rupees One Lakh Sixty Seven Thousand and Ninety Seven only) for the payment of consolidated pay to Tmt.Dr.Suma Abraham, for the period from January 2014 to 24.05.2014.

5. The amount sanctioned in para 4 above shall be credited to the following head of account:-

Pending provision of funds in Revised Estimate/ Final Modified Appropriation 2014-2015 the Director of Medical Education is authorized to draw and incur the expenditure and she is requested to include the expenditure sanctioned above while sending the Budget proposal for Revised Estimate/ Final Modified Appropriation 2014-2015 to Finance (Health-II) Department without fail.
