### **ORDER:**

The Hon'ble Chief Minister under Rule 110 has announced in the floor of the assembly that New buildings will be constructed to the Auxiliary Nursing Midwife (ANM) Schools at Egmore, Poonmallee and Villupuram at a cost of Rs.17.20 crore.

2. The Auxiliary Nursing Midwife training schools are functioning in the premises of Regional Training Institute (RTI) at IPH Poonamallee and Egmore and at HMDI Villupuram. The Regional Training Institutes and HMDI training schools are conducting many inservice training programmes. It has been proposed to provide new separate buildings to the Auxiliary Nursing Midwife Schools in Poonamallee, Egmore and Villupuram, as per the Indian Nursing Council Norms at a total cost of Rs.1720 lakhs, for civil works and under infrastructure.

3. In this regard, the proposal has been included in Programme Implementation Plan 2018-19 for constructing new buildings to 3 Auxiliary Nursing Midwife Schools.

4. The proposal was approved in the Record of Proceedings 2018-19 by the Government of India with the budgetary provision of Rs.171.99 lakhs for constructing new buildings for Auxiliary Nursing Midwife schools at 10% of the total requirement of Rs.1720 lakhs.

5. The civil works are to be executed through Public Works Department and other infrastructure such as class room furniture, kitchen ware, water supply etc., are to be provided through the concerned head of the institutions.

6. The balance of funds required in this regard are to be proposed in the subsequent Programme Implementation Plan.

7. The above proposal has been approved by the Executive Committee. However, the Mission Director, National Health Mission has stated that it has been now decided to reallocate the funds among the Auxiliary Nursing Midwife Schools,

as detailed below, for constructing new buildings at the total cost as noted against each of them, considering the existing facilities in the premises of Auxiliary Nursing Midwife Schools. It is also decided to allocate a sum of Rs.50 lakh, out of the funds Rs.171.99 lakh approved in Record of Proceedings 2018-19, to provide furniture to the Training Centre Buildings constructed under National Health Mission in Samayanallur, Madurai district. Besides, in respect of Auxiliary Nursing Midwife School building, proposed to be built in HMDI Campus, Villupuram, it has been now decided to construct the Auxiliary Nursing Midwife School buildings in the campus of UG Primary Health Centre Iruvelpattu, Thiruvannainallur Block, Kallakurichi Health Unit District, Villupuram District, with an intention to develop an another alternate Training School campus near HMDI, Villupuram at a distance of 10kms from HMDI, Villupuram. Also space is not a constraint in the proposed premises.

Therefore, the new building to the above mentioned Auxiliary Nursing Midwife Schools may be constructed at the total cost, as noted against each of them, on reallocation of funds in supersession of the agenda vide No 15 , approved in the 35<sup>th</sup> Executive Committee Meeting held on 16.05.2018 and necessary approval has also been obtained.

8. The fund Rs.50 lakh allocated for provision of furniture to the Training Centre Buildings Samayanallur, Madurai District is to be released separately. The funds allocated for the provision of furniture and others to 3 new Auxiliary Nursing Midwife School buildings shall be released later, on receipt of funds from Government of India.

9. The Mission Director, National Health Mission has requested necessary orders in this regard.

10. The Government after careful examination decided to accept the proposal of the Mission Director, National Health Mission and accordingly order as follows:

- i. Administrative sanction is accorded to construct new buildings to 3 Auxiliary Nursing Midwife Schools as detailed below at a total cost of Rs.1525 lakh for civil works.

- ii. Financial Sanction of Rs. 121.99 lakhs be sanctioned for executing the civil works through Public Works Department.
- iii. The Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.
- iv. The Mission Director, State Health Society – Tamil Nadu, Chennai is permitted to remit the balance of funds required for constructing new buildings to 3 Auxiliary Nursing Midwife Schools as and when the funds are approved by Government of India.

11. The expenditure sanctioned in para 10 (ii) above shall be debited to the following Head of account:-

“ 4211-00 Capital Outlay on Family Welfare-103 Maternity and Child Health State's Expenditure-AA civil works under National Health Mission Scheme-16 major works”.
