



Abstract

National Health Mission – State Health Society – Tamil Nadu - Strengthening of Secondary Care Hospitals – Provision of additional facilities to 9 Sub District Hospitals at total cost of Rs.4200 lakh – A sum of Rs.4.20 crore –Sanctioned – Orders – Issued.

ORDER:

The Hon'ble Chief Minister under Rule 110 has announced on the floor of the assembly on 14.6.2018 that Provision of additional facilities to 9 Sub District Hospitals may be provided for Strengthening of Secondary Care Hospitals at total cost of Rs.42.00 crore.

2. In order to provide better health care facilities it is essential to strengthen the Secondary Care Hospitals, by providing additional facilities to them, based on the gap analysis done in order to cope with the increased demand for health services. In this regard, a detailed proposal has been included in PIP 2018-19, for strengthening of 7 Secondary Care Hospitals detailed below, for providing a G+2 buildings at a total cost of Rs.4200 lakhs.

3. The above proposal is approved in Record of Proceedings by the National Programme for Coordination Committee Government of India, for providing additional facilities to the 7 Secondary Care Hospitals, at a total cost of Rs.4200 lakh, (600 lakh per Institution) with budgetary provision of Rs. 420.00 lakh for the year 2018-19, at 10% of total cost. The balance of funds required is to be proposed in subsequent Programme Implementation Plans.

4. Considering the necessity of requirements, it has been decided to provide additional facilities to 2 more hospitals – viz., Government Hospital Arani, Tiruvannamalai District and Government Hospital Panrutti, Cuddalore District, by reallocation of the funds approved for 7 Secondary Care Hospitals in Record of Proceedings 2018-19. Thus, the funds are reallocated as detailed below, for providing additional facilities to 9 Secondary Care Hospitals.

5. The above proposal has been approved by the Executive Committee in the 35th Executive Committee Meeting held on 16.05.2018.

6. The fund Rs. 420 lakhs, approved for the year 2018-19, at 10% of the total cost of Rs. 4200 lakhs, for providing additional facilities to 9 Secondary Care Hospitals as detailed above, remitted into Government account, as per the directions issued in G.O(Ms)No.116, Health and Family Welfare (EAP II -2) department, dated 25.03.2011.

7. The Mission Director, National Health Mission has requested necessary orders in this regard.

8. The Government after careful consideration decided to accept the proposal of the Mission Director, National Health Mission and accordingly order as follows:-

- i. Administrative sanction is accorded to construct G+2 buildings in 9 Secondary Care Hospitals as detailed below, at a total cost of Rs.4200 lakh, for providing additional facilities to them;

- ii. Sanction is accorded for a sum of Rs. 4.20 crore (Rupees four crore twenty lakh only) for executing the civil works through Public Works Department.
- iii. The Engineer in Chief and Chief Engineer (Buildings) Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds.
- iv. The Mission Director, State Health Society – Tamil Nadu, Chennai is permitted to remit the balance of funds required for these civil works as and when the funds are approved by Government of India.

9. The amount sanctioned in para 8(ii) shall be debited to the following Head of account

"4211-00 capital outlay on family welfare-103 Maternity and Child Health State's Expenditure – AA civil works under National Health Mission Scheme-16 major works".
