**ORDER:**

In Government Order first read above, orders have been issued approving the policy / prospectus for admission to Post Graduate Degree / Diploma courses in Government Medical Colleges and Government quota Seats in Self-Financing Medical colleges affiliated to the Tamil Nadu Dr.M.G.R Medical University for the academic year 2023-2024 session.

2. The Hon'ble High Court of Madras in its order dated 26.07.2023 in W.P.No.436 of 2023 has directed the Deputy Director, Directorate of Medical Education to discuss the implementation of bond service for Non-service Post Graduate by constituting a committee.

3. According to the Director of Medical Education and Research's letter second read above, a committee was formed in response to the Honourable High Court of Madras observation in W.P.No.436 of 2023, and during the meeting regarding the implementation of the bond condition for Non- Service Post Graduates, the following suggestions were put forward by the committee members.

- i. Extending one year after their Post Graduation, as Senior Resident Compulsorily instead of 2 years compulsory service to fulfil bond conditions with stipend.

(or)

To create the supernumerary posts in the Government Medical Colleges to accommodate Non-Service Post Graduates

- ii. To reduce the bond amount for Non Service Post Graduates to Rs.20,00,000/- (Rupees Twenty lakh only) instead of Rs.40,00,000/- (Rupees Forty lakh only)

- iii. To issue bond posting to the Non-Service Post Graduates in the same speciality.
- iv. To reduce the bond period from 2 years to 1 year for Non-Service Post Graduates
- v. To issue the bond postings to Non-Service Post Graduates on time (1-3 months)
- vi. To release the original certificates of Non-Service Post Graduates, if the Posting order is not issued on time.

4. The Director of Medical Education and Research has further sent proposal for implementation of revised bond condition for Non-Service Post Graduates who have completed their Post Graduate Diploma courses during the year 2023 in Madras Medical College, Chennai and Government Medical College and Hospital, Cuddalore and has proposed the following:-

- i. To reduce the bond amount for Non-Service Post Graduates (Post Graduate Diploma) to Rs.10,00,000/- (Rupees Ten lakh only) instead of Rs.20,00,000/- (Rupees Twenty lakh only)
- ii. To reduce the compulsory service from 2 years to 1 year for Non-Service Post Graduate Diploma (2 years) candidates after completion of their Post Graduate Diploma Course

5. The Director of Medical Education and Research has requested the Government to issue necessary instructions to proceed further on the implementation of bond conditions for Non-service Post Graduate to Post Graduate Degree / Diploma courses in Tamil Nadu Government Medical Colleges.

6. The Government, hereby issues the following orders regarding the implementation of the bond requirement for Non Service Post Graduates to Post Graduate Degree / Diploma courses in Tamil Nadu Government Medical Colleges after carefully reviewing the request of the Director of Medical Education and Research and the suggestions made by the committee members:-

- i. The bond period for Non Service Post Graduates (Degree/ Diploma) who have completed their Post Graduate courses in the year 2023 will be reduced from two years to one year (from the date of joining in the bond service) and the respective prospectus for the Post Graduate Degree course for the academic year 2020-2021 as well as for the Diploma course for the academic year 2021-2022 will be amended accordingly.
- ii. The bond amount for the Non Service Post Graduates who have completed their Post Graduate Degree courses in 2023 will be Rs.20,00,000/- only (Twenty lakhs) instead of Rs.40,00,000/- (Forty lakhs) and for the Non Service Post Graduates who have completed their Post Graduate Diploma courses in 2023 will be Rs.10,00,000/- only (Ten lakhs) instead of Rs.20,00,000/- (Twenty lakhs)

- iii. Depending on the need and availability of vacancies in the future, the Health Department henceforth will review and consider the enforcement of 2 years bond condition every year and issue necessary directions for utilizing the services of the Non-service Post Graduates in Tamil Nadu Medical Services and issue appropriate orders.




