ORDER:

In the Government Order second and third read above, among other things, adhoc rules were framed for the posts of Multipurpose Health Assistant and Multipurpose Health Supervisor and for the post of Block Health Supervisor, respectively. In the Government Order fourth read above, the post of Multipurpose Health Assistant and Multipurpose Health Supervisor were re-designated as Health Inspector Grade-II and Health Inspector Grade-I respectively. Accordingly, the adhoc rules were also amended in the Government Order fifth read above. In the Government Order sixth read above, the post of Laboratory Assistants (Malaria) under the Tamil Nadu Public Health Subordinate Service has been included as feeder category to the post of Health Inspector Grade-I, and later, the nomenclature of the post of Laboratory Assistants (Malaria) has been changed as Laboratory Technician Grade-III vide Government Order seventh read above. In the Government Order eighth read above, among other things, the nomenclature viz. Health Inspector Grade-II and Health Inspector Grade-I have been changed as Multipurpose Health Worker (Male) and Multipurpose Health Supervisor (Male),

respectively and the Adhoc Rules for the post of Multipurpose Health Supervisor have been amended.

- 2. The Director of Public Health and Preventive Medicine has stated that there is no saving clause for protecting the right of the person holding the post of Lab Technician Grade-III at the time of issuing amendment for prescribing Educational Qualification in the adhoc rules for the post of Multipurpose Health Supervisor (Male). Hence he has requested the Government to issue a saving clause to protect the right of such Laboratory Technician Grade-III, regarding educational qualification.
- 3. The following Notification will be published in the Tamil Nadu Government Gazette:-

Notification

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules issued with the erstwhile Health, Indian Medicine and Homeopathy and Family Welfare Department, Notification No.SRO B-303/89, published at pages 209-210 of Part III- Section 1 (b) of the <u>Tamil Nadu Government Gazette</u>, dated the 6th September 1989, and subsequently amended. The amendment shall come into effect from 17.10.2013.

AMENDMENT

In the said Rules, after rule 7, the following shall be added, namely:-

"8. Saving Clause – nothing contained in these amendments shall adversely affect any person holding the post on the date of issue of this order."
