ORDER:

In Government Order fourth read above, permission was accorded to the Managing Trustee, Karpagam Charity Trust, Coimbatore District to start the College of Pharmacy in the name and style as “Karpagam College of Pharmacy” to conduct B.Pharmacy Course with an annual intake of 60 students from the academic year 2006-2007 at Othakkalmandapam, Coimbatore District.

2. The Principal, Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore run by Karpagam Charity Trust, Coimbatore has requested the Government to enhance the seats in B.Pharmacy course from 60 to 100 at Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore from the academic year 2020-2021.

3. In Government letter fifth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed pharmacy college has fulfilled the conditions prescribed by the Government in the Government Orders first to third read above and as per the norms of the Pharmacy Council of India, New Delhi.

4. In his letter sixth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Pharmacy Council of India, New Delhi and recommended to grant permission to the Principal, Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore run by Karpagam Charity Trust, Coimbatore to enhance the seats in B.Pharmacy course from 60 to 100 at Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore from the academic year 2020-2021.

5. The Government examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Principal, Karpagam College of Pharmacy, Othakkalmandapam Post, Coimbatore run by Karpagam Charity Trust, Coimbatore to enhance the seats in B.Pharmacy course from 60 to 100 (sixty to hundred) at "Karpagam College of Pharmacy", in S.F. Nos. 636/1A, 637/1A, 763/1A, 763/1B, 763/1C, 763/2, 764/2, 770/2B, 770/2C and 770/2D at Othakkalmandapam Village, Madukkarai Taluk, Coimbatore – 641 032 from the academic year 2020-2021, subject to the following conditions before admitting the students:-

- a) Admission of students shall be made as per the rules fixed by the Government from time to time;
- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said pharmacy college.
- c) The Government have the right to utilize the Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc;
- d) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on re-inspection of the centres.

- e) The Trust should obtain Building Completion Certificate from the competent authority i.e. PWD Engineer.
- f) The Trust should renew and obtain No Objection Certificate from the Fire and Rescue Services Department, Coimbatore from 01.06.2020.
- g) The Trust should obtain Clearance Certificate from the Tamil Nadu Pollution Control Board, Coimbatore District.
- h) The Trust should obtain the recognition / affiliation from the Pharmacy Council of India and the Tamil Nadu Dr. M.G.R. Medical University respectively to the above pharmacy institution.

5. The Director of Medical Education is directed to take necessary further action accordingly.
