1. G. O. (Ms) No. 151, Health and Family Welfare [IM2-2] Department Dated 28.5.2014
2. From the Commissioner of Indian Medicine and Homoeopathy Lr.No.9656/A2/2014, dated 4.9.2014 and 11.9.2014.

ORDER:-

In the G.O first read above, orders have been issued to include the Arignar Anna Government Hospital of Indian Medicine, Chennai and the Government Siddha Medical College, Palayamkottai, Tirunelveli under the control of Commissioner of Indian Medicine and Homoeopathy where the bed strength is more than 200 beds to outsource the posts of Sanitary Hospital Worker, Nursing Assistant Grade-II and security. The Government also sanctioned outsourcing the 83 posts in the above Hospitals and the Commissioner of Indian Medicine and Homoeopathy was directed to submit necessary proposal for the expenditure required towards payment of salary after finalizing the agreement with Agency.

2. In the reference second read above the Commissioner of Indian Medicine and Homoeopathy has informed that it will take some more time to submit proposal for expenditure required towards payment of salary after finalizing the agreement with the agency by Tampcol (Nodal Agency). The Commissioner of Indian Medicine and Homoeopathy has therefore requested the Government to provide a sum of Rs.64,74,000/- (Rupees Sixty Four Lakh and Seventy Four Thousand Only) (calculating average cost per month per personnel as Rs.6500/-x83x12) as interim arrangements so as to provide salary to the outsourced House Keeping Human resource staff and to the hygienic maintenance of Arignar Anna Government Hospital of Indian Medicine, Chennai and Government Siddha Medical College, Palayamkottai.

3. The Government have carefully examined the proposal of the Commissioner of Indian Medicine and Homoeopathy and accord sanction a sum of Rs.63,36,000/- (Rupees Sixty Three lakh and Thirty six thousand only) as interim arrangement to provide salary to the outsourced House keeping Human resource staff and to the hygienic maintenance of Arignar Anna Government Hospital of Indian Medicine, Chennai and Government Siddha Medical College, Palayamkottai

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of account:-

"2210. Medical and Public Health-02. Urban Health Services- Other Systems of Medicine -104. Siddha I. Non Plan – AB State Head Quarters Hospital, Hospital attached to the Government Siddha Medical College, Palayamkottai and attached Pharmacies -33. Payment for Professional and Special Services-04.Contract Payment (DPC 2210-02-104-AB-3345)

5. The expenditure sanctioned in para 3 above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will initially be met by an advance from the Contingency Fund and orders regarding which will be issued by the Finance (BG-I) Department. The Principal Secretary and Commissioner, Indian Medicine and Homoeopathy is requested to send application in the prescribed form along with a copy of this order to Finance (BG-I) Department for sanctioning the advance. The Principal Secretary and Commissioner of Indian Medicine and Homoeopathy is also requested to send necessary note for inclusion of the expenditure in the Supplementary Estimate to obtain approval of the Legislature to the Finance (Health-I/ B Coord.) Department at the appropriate time.
