ORDER:

The Mission Director, National Health Mission has stated that the Government of India have communicated ROP 2020-21 with the approval for National Urban Health Mission Flexible Pool for a sum of Rs.192.91 Crores to the State of Tamil Nadu for the Financial Year 2020-21. Further, during the month of July, Government of India have released 1st tranche of Rs.1,36,00,000/- Grants-in-Aid for creation of capital assets in Ayushman Bharat – Health and Wellness Centres covered under National Urban Health Mission Flexible Pool during the Financial Year 2020-21 and credited into State Government Account for drawal of the said amount through treasury as detailed below:-

- 2. Further, the Mission Director, National Health Mission has stated that, the following activities of Creation of Capital Assets in Ayushman Bharat Health and Wellness Centre covered under National Urban Health Mission Flexible Pool for a sum of Rs.2.27cr is to be undertaken as per Record of Procaeding for the Financial year 2020-21 in Metro and Non-Metro cities from the above requested amount.
 - A sum of Rs.1.30 Crores will be released for the Infrastructure Strengthening of 140 Urban Primary Health Centres into Health and Wellness Centres in Greater Chennel Corporation (FMR + U.5.3.1).
 - ii. A sum of Rs.0.96 Crores for the Infrastructure Strengthening of 320 Urban Primary Health Centres into Health and Wellness Centres in Non-Metro (FMR – L.5,3.1).
- 3. The Mission Director, National Health Mission has requested to issue early orders in this regard.
- 4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.2,26,66,667/- (Rupees Two Crore Twenty Six Lakh Sixty Six Thousand Six Hundred and Sixty Seven Only) towards the Central and State Share for creation of capital assets in Ayushman Bharat Health and Wellness Centres covered under National Urban Health Mission Flexible Pool during the Financial Year 2020-21.
