Nursing Establishment – Enhancing Monthly Contract Payment for Nurses Working in Government Medical College/Hospitals/Institutions Under the control of Directorate of Medical Education on par with the Pay of Contract Nurses working under NRHM&CEmONC Schemes – Orders - Issued.

ORDER:

In the G.O. first read above, orders have been issued among other things to pay a monthly remuneration of Rs.2500/- p.m. for the nurses appointed on contract basis.

- 2. In the G.O. second read above, orders have been issued for enhancing the consolidated pay of 2540 Nurses appointed on contract basis under Reproductive Child Health and Tamil Nadu Health System Project from Rs.2500/- to Rs.3500/-p.m. in the first year, Rs.4000/- p.m. from the second year and Rs.5000/- from the third year till they are regularly absorbed as per seniority in the time scale of pay with effect from 01.09.2006.
- 3. In the G.O. third read above, orders have been issued for enhancing the consolidated pay of these Nurses to Rs.4000/-, Rs.4500/- and Rs.5500/- for the first, second and third years of service respectively.
- 4. Further in the G.Os fourth and fifth read above, orders have been issued among other things that the consolidated pay of these Nurses (employed under NRHM, CEmONC Centres, Project Hospital, NCD Programme in the Government Hospital and Primary Health Centres under the Tamil Nadu Health System Project) be enhanced from Rs.4000/- to Rs.7000/- in the first year, Rs.4500/- to Rs.7500/- in the second year and Rs.5500/- to Rs.8000/- from the third year onwards till they are regularly absorbed with effect from 01.04.2012.

- 5. The post of Staff Nurses in Government Medical College Hospitals and Institutions under the control of Director of Medical Education is a regular permanent sanctioned post and therefore these posts carries time scale of pay. However, certain contract Nurses (viz. 78 numbers) were posted in the Government Medical College Hospitals/Institutions under the control of Director of Medical Education. But, these contract Nurses have not received the enhanced contract pay on par with that of contract Nurses working in CEmONC Centres and at National Rural Health Mission schemes. If the above said individuals allotted to the scheme side, they would have got the enhanced pay on par with others those who got higher pay in the schemes side.
- 6. Meanwhile, representations have been received from certain Contract Nurses working under Director of Medical Education requesting the enhanced contract pay on par with that of Contract Nurses working under CEmONC and NRHM schemes. If the 78 posts occupied by the Contract Nurses in the Director of Medical Education side are allotted to regular candidates, they will be drawing more pay (i.e., regular time scale) than the amount drawn by the Contract Nurses. Hence, there is no extra expenditure to be involved in this case by way of giving the enhanced contract pay to these Nurses.
- 7. The Government after careful examination have decided to enhance the pay of the Contract Nurses working in the Government Medical Colleges/Hospitals/Institutions under the control of the Director of Medical Education, based on the orders issued in G.Os fourth and fifth read above, with effect from 01.04.2012. Accordingly, the Government do and hereby direct that the pay of the contract Nurses working in the Government Medical Colleges/Hospitals/Institutions under the control of Director of Medical Education be enhanced based on the above said G.O. and the Director of Medical Education is directed to issue necessary instructions to the Dean of the respective Institutions, (wherein the 78 Contract Nurses working), to enhance the pay of the Contract Nurses working in their control, based on the orders issued in G.O.MS.No.342, Health dated 14.12.2012 and G.O.MS.No.72, Health dated 10.04.2013 with effect from 01.04.2012.
- 8. This order is issued with the concurrence of Finance Department vide its U.O.No.127/ADS(Dr.P.U)/H.II/2014, dated 27.03.2014.
