ORDER:

In the letter read above, the Project Director, Tamil Nadu Health Systems Project has stated that the Dean, Madras Medical College / Rajiv Gandhi Government General Hospital, Chennai has considered and forwarded the proposal of HLL Life Care Ltd., (A Govt. of India Enterprise) Thiruvananthapuram for setting up of Bone Marrow Transplant Unit at Department of Haematology, Madras Medical College (MMC) / Rajiv Gandhi Government General Hospital (RGGGH) on turnkey basis for a sum of Rs.6.89 Crores.

- 2. The Project Director, Tamil Nadu Health Systems Project has stated that a sum of Rs.6.89 Crore (Rupees Six Crore and Eight Nine Lakh Only) has been sanctioned from Corpus fund as an advance towards the cost of setting up of Bone Marrow Transplant Unit by HLL Life Care Ltd., (A Government of India Enterprise) Thiruvananthapuram at department of Haematology, Madras Medical College (MMC) / Rajiv Gandhi Government General Hospital (RGGGH) Chennai with a condition that the advance given will be recovered by deducting Rs.3.00 lakh per case from the approved surgery cost of Rs.9.46 lakh, exclusive of the tax amount of Rs.63,42,035/- which has not been released to the Dean / Company.
- 3. The Project Director, Tamil Nadu Health Systems Project has stated that on completion of the unit, the Deputy General Manager, HLL Life Care Ltd., raised the claim for the payment of tax. The Head of the Department of Haematology, Rajiv Gandhi Government General Hospital (RGGGH) confirmed the completion of the unit. The inspection report of the team of officials from Tamil Nadu Health Systems Project was since communicated to the Dean for rectifying the defects in order to release the tax amount.
- 4. The Project Director, Tamil Nadu Health Systems Project has stated the Dean has given a report to the effect that the infrastructure work of the unit has been completed and they have started the Bone Marrow Transplant programme. The unit

is functioning satisfactorily and the maintenance work of Bone Marrow Transplant by HLL Life Care Ltd., has to be done upto April 2019. So far, 2 cases of Bone Marrow Transplant (BMT) surgery have been performed in this unit under Chief Minister's Comprehensive Health Insurance Scheme.

- 5. The Project Director, Tamil Nadu Health Systems project has requested to accord permission to release Rs.63,42,035/- from corpus fund, being the tax amount on the cost of Bone Marrow Transplant unit to Dean, Rajiv Gandhi Government General Hospital (RGGGH) with a condition that the amount along with initial amount of Rs.6.89 Crore will also be recovered from Bone Marrow Transplant surgery cost to be approved and paid.
- 6. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project have decided to accept the proposal. Accordingly, the Government ratify the action of the Project Director, Tamil Nadu Health Systems Project in having given an advance of Rs.6.89 crore from Corpus fund of Chief Minister Comprehensive Health Insurance Scheme for setting up of Bone Marrow Transplant Unit at Rajiv Gandhi Government General Hospital, Chennai by HLL Life Care Ltd., (A Government of India Enterprise), subject to the condition that such purchase and other capital expenditure should not be done from the corpus fund without prior approval of the Government.
- 7. The Government also permit the Project Director, Tamil Nadu Health Systems Project to release further amount of Rs.63.42 lakh from corpus fund of Chief Minister's Comprehensive Health Insurance Scheme for payment of Taxes towards purchase of the machine.
- 8. This order issues with the concurrence of the Finance Department vide its U.O.No.4542/Health –II/2019, dated: 13.02.2019
