APPENDIX.

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The Rules hereby made shall be deemed to have come into force on and from the 16th December, 2014.

RULES.

The General Rules for the Tamil Nadu State and Subordinate Service and the Special Rules applicable to the holders of the permanent posts in Branch-IV-General of the Tamil Nadu Medical Subordinate Service shall apply to the holder of the temporary post of Lab Attendant at the Institute of Microbiology, Madras Medical College, Chennai subject to the modifications specified in the following Rules:

Provided that with effect on and from the 15th September 2016, the provisions contained in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts in Branch-I-Medical of the Tamil Nadu Medical Subordinate Service shall apply to the holder of the post.

- 2. <u>Constitution</u>. The post shall constitute a distinct class in the said service.
- 3. <u>Appointment</u>. Appointment to the post shall be made by direct recruitment.
- 4. <u>Qualification</u>.— (a) <u>Age</u>.— No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete thirty two years of age on the first day of July of the year in which the selection for appointment is made;
- (b) Other Qualification.— No person shall be eligible for appointment to the post unless he possesses S.S.L.C qualification, Medically fit, clear vision and capacity for out door work.
- **5.** <u>Probation.</u>— Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.
- 6. Pay.— There shall be paid to the holder of the post a monthly pay calculated in the Pay Band of PB 1 A of Rs.4800 10000 with Grade Pay of Rs.1300:

Provided that with effect from the 1st January 2016, the monthly pay shall be calculated in Level-1 Rs.56100 – 177500 under the Tamil Nadu Revised Pay Rules, 2017.

7. <u>Saving</u>. Nothing contained in these rules shall adversely affect any person holding the post as on the date of publication of these Rules in the <u>Tamil Nadu</u> Government <u>Gazette</u>.
