## ORDER:

In the Government Order first read above, orders have been issued among other things absorption of the Paraplegia Project in the Government General Hospital, Madras to render continuous service, along with the staff mentioned in the Annexure to the said Government Order and necessary fund provision has been made for recurring and non-recurring expenses. In the said Government Order, the post of Steno-Typist had also one among the post absorbed.

2. In her letter second read above, the Director of Medical Education has stated that Tmt.K.Geetha has been sponsored by Employment Exchange for the post of Typist and was appointed temporarily as Typist on 5-11-1981 Forenoon in the Paraplegia Project for a period of two months on a consolidated pay of Rs.335/- per month and she was permitted to continue her service in the Project as Typist till the remaining period of the Project. She was absorbed as Steno-Typist into regular time scale with effect from 1-5-1987, eventhough she has not fully qualified for the post of Steno-Typist. She has, further, stated that when the Tamil Nadu Public Service Commission was consulted in the matter, the Commission has stated that for appointment to the post of Typist, the candidate should pass in both English and Tamil Typewriting with Higher grade in anyone of these. Tmt.K.Geetha fulfills the minimum qualification for the post of Typist only after passing Tamil Typewriting by Lower grade in November 1987. Therefore, she could be appointed to the post of Typist only from the date of passing of Tamil Typewriting. The Commission has also stated that for appointment to the post of Steno-Typist along with the qualifications for the post of Typist, a pass in Both English and Tamil Shorthand with Higher grade in any one of these languages is essential and the individual has acquired only Tamil and English Shorthand Lower. Hence she is not eligible for

appointment to the post of Steno-Typist and therefore, the Director of Medical Education has requested to regularize the temporary services of Tmt.K.Geetha by relaxing the rules.

- 3. Tmt.K.Geetha was working as Steno-Typist, but even she was not eligible to hold the post of Typist neither during the Project period i.e. during the year 1981 nor while absorbing the staff in the Government Order first read above during the year 1987. But, she had been appointed as Steno-Typist, based on the Government Order read above. Hence, the services of the individual cannot be regularised neither in the post of Typist nor Steno-Typist. Further, the services of the individual need not be regularised in the post of Steno-Typist by relaxing the relevant rules as proposed by the Director of Medical Education, as there was sufficient candidates with having technical qualifications for the post of Steno-Typist at that time. But, the individual is continuing in the service till date. Considering this, her services, may be regularised in the post of Typist as she had acquired the required qualification for the post of Typist on 28.11.1987. For this purpose, the post of Steno-Typist sanctioned in the Government Order first read above has to be changed as "Typist."
- 4. The Government after careful examination have decided to issue necessary amendment to the annexure to the Government Order first read above so as to regularize the services of the individual. Accordingly, the following amendment is issued to G.O.(Ms) No.1406, Health and Family Welfare Department, dated 22.07.1981.

## <u>Amendment</u>

The nomenclature of the post of 'Steno-Typist' mentioned in SI.No.11 in the annexure to G.O.(Ms). No.1406, Health and Family Welfare Department, dated 22.07.1987 shall be modified as "Typist".
