**ORDER:**

The Chairman, Velammal Educational Trust, Madurai District has requested the Government to grant permission to start a new College of Nursing in the name and style as “Velammal College of Nursing” at Madurai to conduct B.Sc., (N) course with an annual intake of 50 students from the academic year 2015-2016.

2. Based on the request the Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Nursing, has fulfilled the conditions prescribed by the Government and Indian Nursing Council, New Delhi. The Director of Medical Education has submitted the proposal with the Inspection report / Project Report along with her specific remarks to the Government and requested Government to issue necessary orders.

3. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. Accordingly, Government grant permission to the Chairman, Velammal Educational Trust, Madurai District to start a new College of Nursing in the name and style as “Velammal College of Nursing” at Velammal Village, Madurai -Tuticorin Ring Road, Anuppanadi, Madurai to conduct B.Sc., (N) course with an annual intake of 50 students from the academic year 2015-2016, subject to the following conditions:-

- a) Admission of students shall be made as per the rules fixed by the Government from time to time.
- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be

collected from the students seeking admission in the Private Self Financing Nursing Colleges.

- c) The Trust should obtain recognition / suitability / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, Indian Nursing Council, New Delhi and Tamil Nadu Dr. M.G.R. Medical University respectively before admitting the students.
- d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- e) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- f) The Trust should not run any other Nursing institution within 10 kms radius.
- g) The approval for the building plan from the DTCP should be obtained in due course as per the undertaking of the Trust.
- h) It is also certified that the Velammal Educational Trust, Madurai owns parent / 500 bedded hospital in the name and style as "Velammal Medical College Hospital & Research Institute, Madurai-625 009."

4. The Director of Medical Education is directed to take necessary further action accordingly.
