Government of India have transferred and credited into State Government Account its share towards Grants-in-aid for Reproductive and Child Health Flexible Pool including other Programmes during 2017-18 as detailed below:-

3. The corresponding 40% of the State Share against the 60% of the Government of India release of 14,72,00,000/- (Rupees fourteen crore and seventy two lakh only) works out to Rs.9,81,33,333/- (Rupees nine crore eighty one lakh Thirty three thousand three hundred and thirty three only).

4. The Mission Director, State Health Society has requested the Government to issue orders for the release of a sum Rs.24,53,33,333/-

(Rupees Twenty four crore Fifty three lakh thirty three thousand three hundred and thirty three only) towards the Grants-in-aid for Reproductive and Child Health Flexible Pool including other Programmes during 2017-18 as mentioned above and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs.24,53,33,333/- (Rupees twenty four crore fifty three lakh thirty three thousand three hundred and thirty three only) under National Health Mission through Treasury mode and credit it into State Health Society Account.

The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.24,53,33,333/- (Rupees twenty four crore fifty three lakh thirty three thousand three hundred and thirty three only) towards Grants-in-aid for RCH Flexible Pool including other Programmes during 2017-18.
