ORDER:

During 2020-2021 on the floor of the Assembly, the Hon'ble Chief Minister under rule 110 Tamil Nadu Legislative Assembly has made the following Announcement:-

"சென்னை ஓமந்தூரார் அரசினர் தோட்ட வளாகத்தில் உள்ள தமிழ்நாடு அரசு பன்னோக்கு உயர் சிறப்பு மருத்துவமனையில், கடினமான அறுவை சிகிச்சை துல்லியமாகவும், விரைவாகவும் உயர் தொழில் நுட்பத்தைப் பயன்படுத்தி சிறப்பான சிகிச்சை அளிக்க நவீன Robotic அறுவை சிகிச்சை மையம் 34.60 கோடி ரூபாய் மதிப்பீட்டில் நிறுவப்படும் (24.03.2020)"

- 2. Based on the above announcement, the Director of Medical Education has sent the proposal submitted by the Director, Tamil Nadu Government Multi Super Speciality Hospital, Chennai for starting of "Advanced Robotic Surgery Centre" in Tamil Nadu Government Multi Super Speciality Hospital (Block-A) Omandurar Government Estate, Chennai and has furnished the benefits of Advanced Robotic Surgical system.
- 3. The Director of Medical Education has stated that among the three currently available Robotic Systems, the "Da Vinci Surgical System" has been developed over 20 years ago, the platforms have pioneered new capabilities in the Operation Theatre transforming the field of minimally invasive surgery. He has furnished the specifications for Robotic Surgical system with accessories and also furnished the following other requirements.

A.TRAINING:

1. Surgeon Training:

Six surgeons nominated in a phased manner by the Institution Head shall be trained and certified by the vendor for using the system to perform robot assisted surgeries. The duration of the training and the training method shall be as perinternational norms at an authorized training centre.

2. Operation Theatre Staff Training:

A set of Operation Theater Staff such as Nurses and Operation Theater technicians and Biomedical staff shall be trained by the vendor for handling the system covering powering on, moving and positioning the system and observing the system for right function and errors if any etc. The training method and duration shall be outlined by the vendor. There may be multiple batches of Operation Theater Staff required to be trained over a period of time.

B. INSTRUMENTS, CONSUMABLES & ACCESSORIES:

The vendor should provide a list of Instruments, Consumables and Accessories available for the use of the system for benign and cancer surgeries suitable for the capabilities of the system. The system should be supplied with the Starter Kits of Instruments, Accessories & Reusable for approx 200 procedures.

C. SPECIAL ADDITIONAL EQUIPMENTS:

Vendor to specify any special additional equipment that may be required for the use of the robotic surgery system such as special cleaning and sterilization equipment and UPS with adequate back up capacity.

D. ENVIRONMENT AND POWER:

All equipment shall be capable of working on 230 V AC, +/- 5%, 50 Hz Power Supply. The system shall be capable of working between 22 to 30Deg C air-conditioned environment.

E. SPARES and ACCESSORIES:

A minimum set of Emergency spares that may be required for immediate replacement during procedures. A set of Reusable accessories required for common procedures shall also be proposed.

4. The Director of Medical Education has therefore requested the Government to accord administrative and financial sanction for a sum of Rs.34.60 crore for

starting of Advanced Robotic Surgery Centre in Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate (Block A), Chennai.

- 5. The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.34.60 crore (Rupees thirty four crore and sixty lakhs only) for starting of Advanced Robotic Surgery Centre at Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate (BLOCK A), Chennai.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following Head of Account:-

"2210 - Medical and Public Health - 01 Urban Health Services - Allopathy - 110 Hospitals and Dispensaries - State's Expenditure EA - Establishment of Multi Super Speciality Hospital at Omandurar Government Estate, Chennai-319 - Machinery and Equipments 01 Purchase (Old DPC 2210 01 110 EA 1914) (IFHRMS DPC 2210 01 110 EA 31901)

7. The Director of Medical Education is directed that the amount sanctioned in para 5 above shall not be paid in cash but credited to the following Personal Deposit Account of the Tamil Nadu Medical Services Corporation Limited:-

"K Deposit and Advance (b) Deposits not bearing interest — 8443.00 — Civil Deposit — 800 — Other Deposits — CE Deposits of Tamil Nadu Medical Services Corporation Limited (TNMSC) 801 Receipts — 02 Not Bearing Interest" (Old DPC 8443-00-800-CE-000H) (Receipts) (IFHRMS DPC 8443-00-800-CE-80102) (Receipts)

8. The expenditure sanctioned in para-5 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2020-2021 to Finance Health-II (BG-I) Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No. 107/Health-II/2021 dt.25/01/2021 and ASL No. 1491(One Thousand Four Hundred Ninety One.)
