ORDER:

In the Government Order first and second read above, the Government had appointed ten candidates to the post of Health Officer in Tamil Nadu Public Health Service based on the selection made by the Tamil Nadu Public Service Commission.

- 2. In the Government Order third read above, the Government have appointed <u>four</u> candidates to the post of Health Officer in Tamil Nadu Public Health Service, based on the selection supplementally made by the Tamil Nadu Public Service Commission.
- 3. In the Government order fourth read above, the Government have regularised the services of the 6 candidates among the 14 candidates appointed by the Government in the Government Order first, second and third read above.
- 4. The Director of Public Health and Preventive Medicine in his letter fifth read above has stated among others that only 8 candidates out of 14 candidates selected by the Tamil Nadu Public Service Commission have joined duty and continued in service. Among the 8 candidates, the services of the six Health Officers have been regularised in the G.O.(Ms).No.160, Health and Family Welfare (L2) Department, dated:04.06.2015. He has further stated that the remaining two candidates viz;

Dr.M.Anitha and Dr.M.Yazhini, Health Officers have joined duty on 21.07.2014 and completed Orientation Training Course at the Institute of Public Health, Poonamallee during the period from 21.07.2014 to 20.10.2014 and joined duty as Health Officer in Tamil Nadu Public Health Service. He has, therefore, requested the Government to regularise the services of Dr.M.Anitha and Dr.M.Yazhini, Health Officers with effect from their date of joining in the Orientation Training Course.

- 5. The Government, after careful examination direct that the temporary services of Dr.M.Anitha and Dr.M.Yazhini, Health Officers in the Tamil Nadu Public Health Service be regularized under section 3(o)(i) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 with effect from 21.7.2014 i.e. the date of their joining in the Orientation Training Course.
- 6. The Government also direct that the above regularization is subject to the final orders to be passed in the writ petitions, if any, pending before the Hon'ble High Court of Madras / Madurai Bench of Madras High Court, Madurai relating to this recruitment.
- 7. Consequent on the retrospective regularization of their temporary services, they are eligible to draw arrears of increment, if any.
