## ORDER:-

In the Government Order first read above, among others Government have sanctioned a sum of Rs.90,000/- towards vehicle hire charges to the Tamil Nadu Government Multi Super Speciality Hospital, Chennai.

- 2. In the reference second read above the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, has stated that the Tamil Nadu Government Multi Super Speciality Hospital is functioning from 21.2.2014 and works are going on round the clock. The proposal for the purchase of a new vehicle and also the diversion of vehicle surrendered to the common pool is also awaited with fuel allotment. Hence they depend only in the hired vehicle at present. In the Government Order read above, the Government have already sanctioned a sum of Rs.90,000/- (Rupees Ninety thousand only) towards vehicle hire charges to the Tamil Nadu Government Multi Super Speciality Hospital, Chennai. The sanctioned amount has been fully utilized. Hence, the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Chennai has requested the Government to sanction a further amount of Rs.90,000/- (Rupees Ninety thousand only) to extend the above hired vehicle, until the allotment a vehicle by the Government.
- 3. The Government after careful consideration accept the proposal of the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Chennai. Accordingly sanction is accorded for a sum of Rs.90,000/- (Rupees Ninety

thousand only) to utilise the hired vehicle for the use of Tamil Nadu Government Multi Super Speciality Hospital, Chennai until the Government allot a vehicle.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:

"2210-Medical and Public Health – 01 Urban Health Services – Allopathy -110 – Hospitals and Dispensaries – I – Non Plan – EA – Establishment of Multi Super Speciality Hospital at Omandurar Government Estate, Chennai - 21- Motor Vehicles 03. Hire Charges.

- 5. Necessary funds will be provided in the RE / FMA 2014 -15 pending provision of funds in RE / FMA 2014 -15. The Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 3 above. The Director of Medical Education is directed to include this expenditure while sending the budget proposals for RE / FMA 2014 -15 to Government in Finance (Health-II) Department without fail.
