#### **ORDER:**

The Secretary, G.S. Pillay and Sons Charitable and Educational Trust, Nagapattinam has requested the Government to grant permission to start four years B.Sc (Nursing) course in the name and style as "E.G.S Pillay College of Nursing", Thethi, Nagore Village, Nagapattinam from the academic year 2021-2022.

- 2. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.
- 3. In his letter eighth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council and recommended to grant permission to the Secretary, G.S. Pillay and Sons Charitable and Educational Trust, Nagapattinam to start four years B.Sc (Nursing) course in the name and style as "E.G.S Pillay College of Nursing", Thethi, Nagore Village, Nagapattinam with an annual intake of 60 seats from the academic year 2020-2021.
- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Secretary, G.S. Pillay and Sons Charitable and Educational Trust, Nagapattinam to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) seats in the name and style as "E.G.S Pillay College of Nursing" in S.F. No. 163/2 at Thethi Village, NagapattinamDistrict 635 806 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:
  - i. The Trust should obtain approval from DTCP for boys and girls Hostels.
  - ii. The Trust should run only E.G.S Pillay College of Nursing in S.F.No. 163/2 at Thethi Village, Nagapattinam District.
  - iii. The Trust should provide adequate remaining library books.
  - iv. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

5. The Director of Medical Education is directed to take necessary further action accordingly.
