ORDER:

In the Budget Speech for 2014-2015, Hon'ble Finance Minister has made an announcement among others, that a Speciality Tower Block will be constructed at Government Stanley Hospital, Chennai at a cost of Rs.75 crores.

- 2. Based on the above announcement, the Director of Medical Education has forwarded the rough cost estimate for construction of Speciality Tower Block by demolishing the existing dilapidated old buildings at Government Stanley Hospital, Chennai for an amount of Rs.75.00 crores in the schedule of rates for the year 2014-2015 prepared and approved by the Engineer-in-Chief and Chief Engineer (Buildings), Chennai, Chennai region and the Chief Engineer (General), Public Works Department, Chennai, duly countersigned.
- 3. The Director of Medical Education has stated that the cost of retrievable materials comes up to Rs.48,26,487/- and after deducting the cost of dismantling the old dilapidated building, the net salvage value comes to Rs.14,33,905/-, which is a revenue to the Government. The details of cost involved is summarized below: -

- 4. The Director of Medical Education has therefore requested the Government to accord administrative and financial sanction for a sum of Rs.75.00 crores for the year 2014 2015, for the construction of Speciality Tower Block and permission to demolish the existing dilapidated old buildings at Government Stanley Hospital, Chennai.
- 5. The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.75.00 crores (Rupees Seventy Five crores only) in the Schedule of Rates for the year 2014 -2015, for the construction of Speciality Tower Block at Stanley Medical College and Hospital, Chennai and also permit to demolish the existing dilapidated old building and remit the net salvage value of Rs.14,33,905/- (Rupees Fourteen Lakhs Thirty Three Thousand Nine Hundred and Five only) into Government account.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health – 01- Urban Health Services – 110 – Hospitals and Dispensaries (Including Pharmacy) - Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings – 16 Major Works" (DPC 4210-01-110-JA-1602)".
