



ABSTRACT

COVID- 19 – Permission to the Director of Medical Education to continuing the services of Lab Technicians and Multipurpose Health Workers engaged to COVID-19 Centres in Government Medical Institutions on contract basis for a further period of four months from 01.12.2021 to 31.03.2022 – Granted - Orders- issued.

ORDER:

In Government Order first read above among others, the Government have permitted the Director of Medical Education to engage 1595 human resources in the cadre of Lab Technician and Multi Purpose Health Workers for the COVID-19 centres in the Government Medical Institutions through outsourcing for a period of three months from the date of filling up of the post as per the rules and regulations in force. In Government Orders second and third read above, the services of the above Outsourced Human Resources has been subsequently extended from time to time.

2. In Government Order fourth read above, the Government have permitted the Director of Medical Education to continue the services of existing outsourced human resources in the cadre of Lab Technicians and Multipurpose Health Workers on contract basis temporarily through the District Health Society as per National Health Mission norms for a further period of six months from 1.6.2021 to 30.11.2021. In the said Government Order, the Government have also accorded financial sanction for a sum of Rs.5,52,30,000/- from State fund and Rs.6,61,80,000/- from the National Health Mission funds towards the wages for the above said 1595 contract employees.

3. Now, the Director of Medical Education in his letter fifth and sixth read above, has furnished the details of men in position, balance fund and the fund requirement based on men in position and sanctioned posts as follows:-

4. The Government have examined the proposal of the Mission Director, National Health Mission in detail. The fund required by the Director of Medical Education as per sanctioned post for a period of three months are Rs.6,07,05,000/- and the Director of Medical Education had Rs.3,31,31,658/- as on 31.12.2021 in his account. Hence, the actual fund requirement involved in this proposal is Rs.2,75,73,342/- only. As excess of fund already available with Director of Medical Education for both the requirements as per sanctioned post and as per men in position for a period of three months, it is considered that, release of State fund seems not necessary. After examination, the Government have do and hereby accordingly issue orders on the following:-

- i. The action of the Director of Medical Education in having continued the temporary services of 25 Lab Technicians and 1067 Multipurpose Health Workers on contract basis in COVID centres during the month of December 2021 without Government orders is ratified.
- ii. As the Omicron variant of Covid-19 rapidly increasing day by day, the Director of Medical Education may be permitted to continuing the services of existing Human Resources in the cadre of Lab Technicians and Multipurpose Health Workers working temporarily on contract basis in Covid centres for a further period of four months from 01.12.2021 to 31.3.2022, subject to the terms and conditions prescribed in G.O(Ms).No. 457, Health and Family Welfare department, dated 25.10.2021.
- iii. The Director of Medical Education is permitted to utilize the balance amount of Rs.3,31,31,658/- to disburse the salary for the Lab Technician and Multipurpose Health Workers for the period of three months from January 2022 to March 2022.

- iv. The Mission Director, National Health Mission is requested to release the required funds towards the payments of the above engaged Human Resources to Director of Medical Education, subject to the maximum of the total amount of Rs.3,30,90,000/- for the period of three months (i.e., from Jan 2022 to March 2022), after due verification of attendance of the engaged staff by the Director of Medical Education every month before 3rd of the month.
- v. The Director of Medical Education is directed to release the fund to the concerned institutions within two working dates every month from the receipt of the claim".
