- The Trust should obtain the building completion certificate from the competent authority.
- The Trust should obtain the building plan approval from the ii. Directorate of Town and Country Planning.
- The Trust should obtain Clearance Certificate from the State iii. Pollution Control Board.
- The Trust should renew and obtain No Objection Certificate from the Fire and Rescue Services Department, Cuddalore from 12.04.2020.
- 5. The Director of Medical Education is directed to take necessary further action accordingly.
