ORDER:

The Secretary, Tamil Nadu Public Service Commission in his letter read above has sent the name of two candidates for direct recruitment to the post of Assistant Medical Officer (Ayurveda and Siddha) in the conditional selection pertaining to the verification of Community Claim.

2. The Government approve the selection of the 2 (two) candidates to the post of Assistant Medical Officer (Ayurveda and Siddha) in the Tamil Nadu Medical Service by direct recruitment for the year 2007-08 made by the Tamil Nadu Public Service Commission mentioned in the annexure.

The Government appoint 2 (two) candidates mentioned in the annexure to this order, temporarily as Assistant Medical Officer (Ayurveda and Siddha) in the Tamil Nadu Medical Service, in the Department of Indian Medicine and Homoeopathy subject to the acceptance of the verification of their community claim. If the community claim of the candidates are found to be not genuine, they are liable for such penal and legal action including recovery of salary as a consequence thereof.

4. Among the two candidates, Thiru.S.Raneesh does not possess adequate knowledge in Tamil. He should pass the second class language test in Tamil within a period of two years from the date of their appointment failing which he will be discharged from service.
