ORDER

The Mission Director, State Health Society in his letter second read above has stated that it has been proposed to strengthen the Regional Training Centres with provision of Skill Laboratory under National Rural Health Mission in the year 2011-12 and the detailed proposal had been included in the Programme Implementation Plan (PIP) 2011-12. The National Project Co Ordination Committee (NPCC) has approved the proposals with Budgetary provision of Rs.500.00 lakhs, inclusive of Rs.100.00 lakhs, for civil works required for Skill Laboratory in 5 Regional Training Centres, at the rate of Rs. 20.00 lakhs each. The proposals have been placed in the 15th Executive Committee meeting held on 21.06.2011 vide agenda No.6 and the agenda is approved by the Executive Committee of State Health Society, Tamilnadu. The civil works required for skill Laboratory in the following Regional Training Centres are to be executed through Public Works Department.

The Mission Director, State Health Society has also stated that as per the directions issued in the Government order vide G.O.(Ms.)No.116 Health and Family Welfare Department dated.25.03.2011, the fund Rs.100.00 lakhs approved by Government of India for the above said Civil Works under National Rural Health Mission had been remitted into Government of TamilNadu, under receipt of account vide challan No.6817 dated 06.07.2013 of State Bank of India, Treasury Branch, Thousand Lights, Chennai.

3. The Mission Director, State Health Society has requested the Government orders to permit him to execute the civil works for strengthening of five Regional Training Centres with skill Laboratory as detailed in para one above, at a cost of Rs.100.00 Lakhs through Public Works Department, accordingly the Engineer – in – Chief and the Chief Engineer (Buildings), Public Works Department may be permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds under the head of account '4211-00 Capital Outlay on Family Welfare. The drawal of funds may be allowed from the allotment of Budget Estimate 2014-15 as the funds have been already remitted in Government account.

4. The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly issue the following orders:-

(i) The Mission Director, State Health Society is permitted to execute the Civil Work for strengthening of the five Regional Training centres with skill Laboratory mentioned in para one above at a total cost of Rs.100.00 lakhs.

(ii) The Engineer in chief and Chief Engineer (Buildings) Public Works Department, Chepauk, Chennai is hereby permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds under the head of account "4211-00 Capital out lay on Family Welfare". for the execution of works in the concerned divisions.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account.
