ORDER:

In Government Order fourth read above, permission was accorded to the Chairman, Cross Trust, Nagercoil, Kanyakumari District to start a School of Nursing in the name and style as "Cross School of Nursing" to conduct Diploma in Nursing course at Nagercoil, with an annual intake of 20 students from the academic year 2007-2008.

2. The Chairman, Cross Trust, Nagercoil, Kanyakumari District has requested the Government to grant permission to Up-grade School of Nursing into College of Nursing at Cross College of Nursing, Azhigiyapandiyapuram, Kanyakumari District from the academic year 2019-2020.

3. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to third and fifth to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.

4. In his letter eighth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council and recommended to Up-grade School of Nursing into College of Nursing at Cross College of Nursing, Azhigiyapandiyapuram, Kanyakumari District from the academic year 2020-2021.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Chairman, Cross Trust, Nagercoil, Kanyakumari District to up-grade 20 seats of Diploma in General Nursing and Midwifery Course into B.Sc (Nursing) course and in addition 30 seats of new intake in B.Sc (Nursing) course total by 50 seats at Cross College of Nursing in S.F. No.319/5 at Wattspuram, Therisanam Cope Village, Nagercoil - 629 851 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain completion certificate from the competent authority.
- ii. The Trust should construct its own 100 bedded hospital within a period of one year as mentioned in the undertaking submitted by the Trust.
- iii. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.
