ORDER:

In the Government Order first read above orders have been issued restructuring the posts of Health Officer and Deputy Director of Health Services as Health Officer, Senior Health Officer, Deputy Director of Health Services, Grade-II, and Deputy Director of Health Services, Grade-I, so as to enable the incumbents, to get promotions to the higher level posts.

2. In the Government Order second read above amendments to the Special Rules for the Tamil Nadu Public Health Service have been issued.

3. In the letter third read above the Director of Public Health and Preventive Medicine has requested to issue amendment to the nomenclature change alone in respect of Deputy Director of Public Health and Preventive Medicine (Category 2) as District Health Officer Grade-I and Deputy Director of Public Health and Preventive Medicine (Category 2C) as District Health Officer Grade-II for administrative convenience.

4. The Government after careful examination decided to approve the proposal of the Director of Public Health and Preventive Medicine. Accordingly, the Government do and hereby change the nomenclature in respect of Deputy Director of Public Health and Preventive Medicine (Category 2) and Deputy Director of Public Health and Preventive Medicine (Category 2C) as follows:

1	Deputy Director of Public Health and Preventive Medicine (Category 2)	District Health Officer – Grade I
2	Deputy Director of Public Health and Preventive Medicine (Category 2C)	District Health Officer – Grade II

5. Amendments to the existing rule in Tamil Nadu Public Health Service governed by Special Rules / Adhoc rules shall be issued separately.
