### **ORDER:**

In Government Order sixth read above, permission was accorded to the Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul to start four years B.Sc Nursing course with an annual intake of 60 students in the name and style as "GTN College of Nursing in S.F. No.205/1B2pt, 203/1pt, 2pt, 199/2pt, 200/1pt, 200/2bpt, 200/3bpt, Old Karur Road, Seelapadi Village and Panchayat, Dindigul West Taluk, Dindigul District from the academic year 2019-2020.

2. The Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul has requested the Government to grant permission to enhance the seats in B.Sc (Nursing) course from 60 to 100 at G.T.N. College of Nursing, GTN Nagar, Old Karur Road, Dindigul from the academic year 2020 – 2021.

3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to fifth and seventh read above and as per the norms of the Indian Nursing Council, New Delhi.

4. In his letter ninth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council and recommended to grant permission to the Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul to enhance the seats in B.Sc (Nursing) course from 60 to 100 at G.T.N. College of Nursing, GTN Nagar, Old Karur Road, Dindigul from the academic year 2020 – 2021.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul to enhance the seats in B.Sc (Nursing) course from 60 to 100 (sixty to hundred) at G.T.N. College of Nursing in S.F Nos.200/1PT, 200/2BPT, 200/3BPT, 205/1B2-PT, 203/1PT, 2PT, 199/2PT, Old Karur Road, Seelapadi Village and Panchayat, Dindigul West Taluk, Dindugul District – 624 005 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country Planning (DTCP).
- ii. The Trust should construct its 150 own bedded hospital within a period of three years.
- iii. The Trust should ensure availability of adequate library books as per the INC norms.

- iv. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

6. The Director of Medical Education is directed to take necessary further action accordingly.
