ORDER:

The Managing Trustee, Sri Kalaimahal Educational Trust, Sembanarkoil, Tharangambadi Taluk, Mayiladuthurai District has requested the Government to grant permission to start four years B.Sc (Nursing) course in the name and style as “Kalaimahal College of Nursing”, Mudikandanallur Village, Sembanarkoil, Tharangambadi Taluk, Mayiladuthurai District from the academic year 2020-2021.

2. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.

3. In his letter eighth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council and recommended to grant permission to the Managing Trustee, Sri Kalaimahal Educational Trust, Sembanarkoil, Tharangambadi Taluk, Mayiladuthurai District to start four years B.Sc (Nursing) course in the name and style as "Kalaimahal College of Nursing", Mudikandanallur Village, Sembanarkoil, Tharangambadi Taluk, Mayiladuthurai District with an annual intake of 60 seats from the academic year 2020-2021.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Managing Trustee, Sri Kalaimahal Educational Trust, Sembanarkoil, Tharangambadi Taluk, Mayiladuthurai District to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) seats in the name and style as "Kalaimahal College of Nursing" in Old R.S. No.142-2B, New R.S. NO.142-2B1, Kalahazthinathapuram, Mian Road @ Tharangambadi Taluk, Mayiladuthurai District - 609 309 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country Planning (DTCP).
- ii. As per the INC norms, the Trust should construct its own 100 bedded hospital with in a period of one year for the proposed nursing college as mentioned in the undertaking submitted by the Trust.
- iii. The Trust should ensure availability of adequate library books as per the INC norms.
- iv. The Trust should construct the hostel block within a period of one year as mentioned in the undertaking submitted by the Trust.

- v. As per the INC norms, the Trust should fillup one post of Principal and two posts of Associate Professor.
- vi. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

5. The Director of Medical Education is directed to take necessary further action accordingly.
