ORDER:

In Government Order fourth read above, permission was accorded to the Secretary, PGP Educational and Welfare Society to start the College of Nursing in Namakkal District in the name and style as "PGP College of Nursing and Research" to conduct B.Sc Nursing course with an annual intake of 50 students from the academic year 2006-2007.

2. The Correspondent, PGP College of Nursing and Research, Namakkal run by PGP Educational and Welfare Society, Chennai has requested the Government to grant permission to enhance the seats in B.Sc (Nursing) course from 50 to 100 seats from the academic year 2020-2021.

3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to third and fifth to seventh read above and as per the norms of the Indian Nursing Council, New Delhi.

4. In his letter ninth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Pharmacy Council of India, New Delhi and recommend to grant permission to the Correspondent, PGP College of Nursing and Research, Namakkal run by PGP Educational and Welfare Society, Chennai to enhance the seats in B.Sc (Nursing) course from 50 to 100 seats from the academic year 2020-2021.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Correspondent, PGP College of Nursing and Research, Namakkal run by PGP Educational and Welfare Society, Chennai to enhance the seats in B.Sc (Nursing) course from 50 to 100 seats (fifty to hundred) in “, PGP College of Nursing and Research, Namakkal” in S.F.No. 460/14-A, NH-7, Karur Main Road, Namakkal- 637 207 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Society should obtain building plan approval from the Directorate of Town and Country and Planning (DTCP) for the above nursing institution.
- ii. The Society should construct its own 150 bedded hospital before completion of the academic year 2020-2021 as mentioned in the undertaking submitted by the Society.

- iii. The Society should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

6. The Director of Medical Education is directed to take necessary further action accordingly.
