ORDER:-

In the Government Order first read above orders have been issued to handover the following 4 Primary Health Centres with all Health Sub Centres along with buildings, furniture, vehicles and equipments to the Corporation of Chennai with the staff attached to the Primary Health Centres, be utlised by the Chennai Corporation till they recruit their own staff and on appointment of staff by the Corporation of Chennai, the Public Health Department Staff will be posted in the existing vacancies in the Department of Public Health and Preventive Medicine.

- 1. Semmanchery Primary Health Centre Saidapet Health Unit District (4 Health Sub Centre)
- 2. Manali Primary Health Centre- Thiruvallur Health Unit District (5 Health Sub Centres)
- 3. Porur Primary Health Centre Kanchipuram Health Unit District (13 Health Sub Centres)
- 4. Mugalivakkam Primary Health Centre Kanchipuram Health Unit District (5 Health Sub Centres)

- 2. In the reference second read above the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has requested that the following four Indian System of Medicine wings functioning in the above 4 Primary Health Centres, may also be attached to the Chennai Corporation on the same lines issued in the Government Order first read above and with regard to the staff attached to the Primary Health Centres, the services of existing Indian System of Medicine staff be utilized by the Chennai Corporation till they recruit their own staff and on appointment of staff by the Chennai Corporation the Indian System of Medicine staff will be posted in the existing vacancies in the Department of Indian Medicine and Homoeopathy:
 - 1. Regular Siddha Wing
 - a) Manali
 - b) Porur.
 - 2. National Rural Health Mission Ayurveda Wing
 - a) Mugalivakkam
 - b) Semmanchery
- 3. The Government have examined the proposal of the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy and decided to accept the same. Accordingly, the Government direct that the following four Indian System of Medicine wings functioning in the following four Primary Health Centres along with buildings, furniture and equipments be handed over to the Corporation of Chennai, subject to the condition that the assets handed over shall not be used for any other purpose other than the hospital and no grant will be provided in future.
 - 1) Manali (Regular Siddha Wing)
 - 2) Porur. (Regular Siddha Wing)
 - 3) Mugalivakkam (National Rural Health Mission Ayurveda Wing)
 - 4) Semmanchery (National Rural Health Mission Ayurveda Wing)
- 5. The services of the existing of Indian Medicine and Homoeopathy Department Staff be utilized by the Chennai Corporation till they recruit their own staff and on appointment of staff by the Corporation of Chennai, the Indian Medicine and Homoeopathy Department staff will be posted in the existing vacancies in the Department of Indian Medicine and Homoeopathy.
