#### **ORDER:**

The Chairman, Sri Ram Nallamani Yadava Educational Institutions, Tenkasi, Tirunelveli District has requested the Government to grant permission to start two years D.Pharm course in the name and style as "Sri Ram Nallamani Yadava College of Pharmacy", Tenkasi, Tirunelveli District with an annual intake of 60 seats from the academic year 2019-2020.

2. In Government letter fourth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed pharmacy college has fulfilled the conditions prescribed by the

Government in the Government Orders first to third read above and as per the norms of the Pharmacy Council of India, New Delhi.

- 3. In his letter fifth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Pharmacy Council of India, New Delhi and recommended to grant permission to the Chairman, Sri Ram Nallamani Yadava Educational Institutions, Tenkasi, Tirunelveli District to start two years D.Pharm course in the name and style as "Sri Ram Nallamani Yadava College of Pharmacy", Tenkasi, Tirunelveli District with an annual intake of 60 seats from the academic year 2020-2021.
- 4. The Government examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Chairman, Sri Ram Nallamani Yadava Educational Institutions, Tenkasi, Tirunelveli District to start two years D.Pharm course with an annual intake of 60 (sixty) students in the name and style as "Sri Ram Nallamani Yadhava College of Pharmacy" in the existing building of Sri Ram Nallamani Yadhava College of Engineering in S.F. Nos.22, 23, 26 and 27 at Nallamani Nagar, Kodikurichi Village, Kodikurichi Panchayat, Tenkasi, Tirunelveli District 627 804 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.148, Health and Family Welfare (PME) Department, dated: 24.04.2018 as applicable to this proposal before admitting the students:
  - i. The Trust should obtain building completion certificate from the competent authority. i.e. PWD.
  - ii. The Trust should obtain building plan approval from the Directorate of Town and Country Planning (DTCP) in the name of Sri Ram Nallamani Yadhava College of Pharmacy.
  - iii. The Trust should obtain Clearance Certificate from the Tamil Nadu Pollution Control Board, Tirunelveli.
  - iv. The Trust should obtain No Objection Certificate from the Fire and Rescue Services Department, Tenkasi from 12.03.2020.
  - v. The Trust should run only Sri Ram Nallamani Yadhava College of Pharmacy at Sri Ram Nallamani Yadhava College of Engineering College Campus building.

- vi. The Trust should obtain recognition from the Pharmacy Council of India, New Delhi for the proposed Pharmacy institution.
- 5. The Director of Medical Education is directed to take necessary further action accordingly.
