In the letter read above, The Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Release of Grants-in-Aid for Other Health System activities covered under National Rural Health Mission & Comprehensive Primary Health Care under Health System Strengthening including other programme during 2018-19 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs.36,96,00,000/- (Rupees Thirty six crore and ninety six lakh only) works out of Rs.24,64,00,000/- (Rupees Twenty Four crore and sixty four lakh only).

The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.61,60,00,000/- (Rupees Sixty one crore and sixty lakh only) being the State and Central Share contribution of Grants-in-Aid to the Other Health System activities covered under National Rural Health Mission & Comprehensive Primary Health Care under Health System Strengthening for the year 2018 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.

The Government after careful consideration has decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.61,60,00,000/- (Rupees Sixty one crore and sixty lakh only)being the State and Central Share contribution of Grants-in-Aid to the Other Health System activities covered under National Rural Health Mission & Comprehensive Primary Health Care under Health System Strengthening for the year 2018 2019.
