ORDER:

In the G.O. first read above, among other things, orders were issued sanctioning one post of Special Officer in the cadre of Dean in the scale of pay of Pay Band-IV of Rs. 37,400-67,000 + Grade Pay of Rs.8,800 on temporary basis for a period of one year from the date of employment and it has also been ordered that the said post to fill up from any one of the Dean from Madras Medical College/Stanley Medical College/ Kilpauk Medical College, since the work for getting Letter of Permission from Medical Council of India will need a lot of knowledge.

2. Accordingly, based on the above orders the Government, Dr. R. Vimala, Dean, Madras Medical College, Chennai is placed to hold the additional charge of the post of Special Officer, Government Medical College at Block-B of Omandurar Government Estate, Chennai in the G.O. Second read above. However, the additional charge arrangement for the post of Special Officer/Dean, has delaying the work relating to starting of new Government Medical College at Block-B of the Omandurar Government Estate.

3. The Government, have decided to create the post of Special Officer cum Dean permanently in supersession of the earlier orders issued in para 3(ii) of the Government Order first read above. Accordingly, the Government do and hereby direct that one regular post of Special Officer cum Dean be created permanently in the scale of pay of Pay Band-IV of Rs.37,400-67,000 + Grade Pay of Rs.8,800 to the new Government Medical College at Block-B of the Omandurar Government Estate, Chennai.
