ORDER:

In the Government Order first read above, the Government have issued orders for starting a Government Medical College at Thiruvarur in the year 2007, with an intake of 100 students from the academic year 2008-2009. In the Government Orders second, third and fourth read above, the Government have sanctioned various Medical, Paramedical and Non Medical posts to the above Medical College.

2. The Medical Council of India has increased the prescribed number of posts of Associate Professor, Assistant Professor, Senior Resident and Tutor in the certain specialities for admission of 100 MBBS students, in the year 2010. The Director has stated that there is a shortfall in the various categories of Medical Officer posts, as per the amended Medical Council of India norms. She has furnished the details of posts required as per Medical Council India norms, posts already sanctioned and posts to be newly created as detailed below:-

3. The Director of Medical Education has further stated that these posts are very much essential to fulfil Medical Council of India norms and to recognize of the MBBS Course in Government Thiruvapur Medical College, Thiruvapur. She has therefore requested to sanction the above posts.

4. The Government, after careful examination of the proposal of the Director of Medical Education, accord sanction for nine posts (9) mentioned in columns 3(a) and 3(b) of the annexure to this order, to Government Thiruvapur Medical College, Thiruvapur, for the various Departments on a permanent basis, in lieu of surrender of excess posts of Associate Professor (3 posts) and Assistant Professor (4 posts) mentioned in column 2 of the annexure to this order. The immediate cost for creation of the said 9 posts is Rs. 58.37 lakhs. The savings due to surrender of 7 posts is Rs. 36.22 lakhs. The approximate additional financial commitment involved in the proposal is Rs. 22,15,200/- (Rupees Twenty Two Lakhs Fifteen Thousand and Two Hundred only).

5. The expenditure towards pay and allowances of posts sanctioned in para 4 above shall be debited to the following head of account:-

“2210 – Medical and Public Health – 05 Medical Education, Training and Research–105 Allopathy– I Non Plan – BP – Government Medical College, Thiruvapur – 01 Salaries”
(DPC 2210 – 05 – 105 – BP – 0102)

6. The expenditure sanctioned in para 4 above shall constitute an item of “New Instrument of Service”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from Contingency Fund will be issued by the Government in Finance (BG-I) Department separately. The Director of Medical Education shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Director of Medical Education shall send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate for the year 2014-2015 to Government in Finance Department without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.70041/CMPC/2014, dated 15.12.2014 and ASL No.1739 (One Thousand Seven Hundred and Thirty Nine).
