ORDER:

The Government have issued orders for the upgradation of the Department of Neurology at Madras Medical College/ Government General Hospital, Chennai as "Institute of Neurology" and upgradation of one post of Professor in the Department of Neurology into that of Director of Neurology in the scale of pay of Rs.37400-67000+G.P.8800/-, in the Government order first read above.

- 2. Now the Director of Medical Education has requested to bifurcate the Department of Neurology into Neurology and Neuro Surgery. The Director of Medical Education has stated that the surgery side of Neuro Department i.e., the part of Neuro Surgery also be upgraded as "Institute of Neuro Surgery" with a separate Director.
- 3. In most of the developing countries, the Department of Neuro Surgery has been bifurcated as Surgery and Medicine and thereby Medical Officers working in the department can concentrate on both treatment and research works. She has also justified that the Medical Officers working as Head of Department in the above said department has already reached maximum scale of pay, hence there will be a very meager additional expenditure to the Government.

- 4. The Government have examined the proposal carefully and accord sanction to upgrade the surgical side of Department of Neurology at Madras Medical College/Rajiv Gandhi Government General Hospital, Chennai as "Institute of Neuro Surgery" and also to upgrade one post of Professor as Director, Institute of Neuro Surgery, in the upgraded Institute of Neuro Surgery in the scale of pay Rs.37400-67000+ G.P.8800/-, at an annual average recurring cost of Rs.2400/- per annum (Rupees Two Thousand and Four Hundred only).
- 5. The expenditure towards pay and allowances for the post shall be debited to the following Head of Account:-

"2210-Medical and Public Health -05-Medical Education, Training and Research -105-Allopathy – I. Non Plan – AA – Chennai Medical College – 01 Salaries
