ORDER:

The Director of Medical Education in her letter read above, has sent the proposal for construction of Cafeteria and separate Common room for male and female students in Government Mohan Kumaramangalam Medical College, Salem.

2. The Director of Medical Education has stated that as per the Medical Council India norms due to increase of seats from 75 to 100, construction of Cafeteria and separate Common room for male and female students and Dean quarters has been proposed in the existing site available in Government Mohan Kumaramangalam Medical College, Salem. The rough cost estimate has been prepared based on the current plinth area rate for the year 2013-2014 and the amount works out to Rs. 121.60 lakhs as detailed below:-

3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Trichy Region, based on the schedule of rates for the year 2013-2014 and has requested the Government to accord administrative and financial sanction for a sum of Rs.121.60 lakhs for the construction of Cafeteria and separate Common room for male and female students and Dean quarters in Government Mohan Kumaramangalam Medical College, Salem.

4. The Government have examined the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.90.00 lakhs (Rupees Ninety Lakhs only) for the construction of Cafeteria and separate Common room for male and female students in Government Mohan Kumaramangalam Medical College, Salem.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account :-

“4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 – Hospitals and Dispensaries (Including Pharmacy) Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings - 16 Major Works.”
(DP Code 4210-01-110-JA -1602.)

6. The expenditure sanctioned in para 4 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of Legislature, the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department separately. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in Supplementary Estimate for the year 2014-2015 to Government in Finance Department at the appropriate time without fail.
