### **ORDER:**

The Director of Medical Education in her letters read above, has sent the proposal for construction of Resident quarters for Junior and Senior Residents and construction of CRRI quarters for boys and girls in Government Mohan Kumaramangalam Medical College, Salem.

2. The Director of Medical Education has stated that the proposed building of Resident quarters for Junior and Senior Residents in Government Mohan Kumaramangalam Medical College Hospital, Salem is needed, as there is no separate quarters for accommodation of Junior and Senior Residents as prescribed by the Medical Council of India. He has further stated that the proposed building of CRRI quarters for boys and girls at the Medical College is needed so as to fulfil the Medical Council India requirements and as there is already shortage of rooms in the CRRI quarters for accommodation of boys and girls.

3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Trichy Region, and has requested the Government to accord administrative and financial sanction for the construction of Resident quarters for Junior and Senior Residents and construction of CRRI quarters for boys and girls in Government Mohan Kumaramangalam Medical College, Salem.

4. The Government, after careful examination, accept the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.855.93 lakhs (Rupees Eight Crore Fifty Five Lakhs and Ninety Three Thousand only) to the Government Mohan Kumaramangalam Medical College, Salem as detailed below:-

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account :-

“4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 – Hospitals and Dispensaries (Including Pharmacy) Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings - 16 Major Works.”

6. The expenditure sanctioned in para 4 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of Legislature, the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department separately. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in Supplementary Estimate for the year 2014-2015 to Government in Finance (BG-I) Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.65898/Health/2014, dated:15.12.2014 and ASL No.1736 (One Thousand Seven Hundred and Thirty Six).
