From the Director of Medical Education letter Ref.No.36533/P&D1/1/2014, dated.14.06.2014 and 26.06.2014.

ORDER:

The Director of Medical Education in her letters read above, has sent the proposal for construction of second floor over the existing first floor and head room in the third floor of Library Block in Chengalpattu Medical College, Chengalpattu to meet out the Medical Council of India requirements.

2. The Director of Medical Education has stated that as per Medical Council of India norms, there shall be an air-conditioned Central Library (1600 Sq.m) with seating arrangement for atleast 200 students for reading with good lighting and ventilation and space for stocking and display of books and journals. The existing Central Library at Chengalpattu Medical College, Chengalpattu is in an area of 1130 Sq.m (both ground and first floor). The foundation of the building has been designed to take the load of Ground plus 2 floors. The Director of Medical Education has therefore requested the Government to accord administrative and financial sanction for a sum of Rs. 70.60 lakhs in the schedule of rates for the year 2013-2014 and Rs. 77.66 lakhs for the year 2014-2015 by adding 10% escalation charges. He has countersigned and forwarded the rough cost estimate prepared by the Superintending Engineer (Buildings), Public Works Department, Chennai, for the above construction.

3. The Government after careful examination of the proposal of the Director of Medical Education, accord administrative and financial sanction for a sum of Rs.77.66 lakhs (Rupees Seventy Seven Lakhs and Sixty Six Thousand only) for the construction second floor over the existing first floor and head room in the third floor of Library Block in Chengalpattu Medical College, Chengalpattu, based on the schedule of rates for the year 2014-2015.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account :-

“4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 – Hospitals and Dispensaries (Including Pharmacy) Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings - 16 Major Works.”
(DP Code 4210-01-110-JA -1602.)

5. The expenditure sanctioned in para 3 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of Legislature, the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department separately. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in Supplementary Estimate for the year 2014-2015 to Finance Department at the appropriate time without fail.

6. This order issues with the concurrence of Finance Department vide its U.O.No.65251/Health II/2014, dated:15.12.2014 and ASL No.1744 (One Thousand Seven Hundred and Forty Four).
