ORDER:

In the Government orders first to seventh read above, orders have been issued for sanction of seats for Diploma in General Nursing and Midwifery course for the 23 Schools of Nursing. It has been brought to the notice that some of the Government Schools of Nursing running Diploma in General Nursing and Midwifery programme have not obtained "Suitability Order" from the Indian Nursing Council to run the programme and that the intake of students per annum is not as per the norms of the Indian Nursing Council. Further, the Indian Nursing Council has issued a list of School of Nursing recognized for conducting the GNM course for the academic year 2014-2015. Out of 23 Schools of Nursing, the Indian Nursing Council has recognized only 11 and the number of seats have been reduced from the sanctioned strength. In order to sort out the issue, meetings were conducted on 01.09.2014 and 03.09.2014 and was decided to redistribute the total Diploma in General Nursing and Midwifery seats among the 23 Schools of Nursing as per the Indian Nursing Council norms.

- 2. Based on the decision taken during the meetings, the Director of Medical Education in her letter eighth read above has sent the proposal to Government for redistribution of seats among the 23 Schools of Nursing having more than 100 seats and for enhancement of intake of seats in the Schools of Nursing having in which the Schools of Nursing attached with 300 bedded hospitals in order to fulfill the norms prescribed by the Indian Nursing Council and for the betterment of the students and requested necessary orders in this regard.
- 3. The Government, have examined the case in detail in the light of the norms of the Indian Nursing Council and the request of the Director of Medical Education and have decided to accept it. Accordingly, the Government grant permission to the Director of Medical Education to redistribute the DGNM seats evenly to the 23 Government Schools of Nursing as annexed to this Government order, in order to get necessary recognition from the Indian Nursing Council and Tamil Nadu Nurses and Midwives Council.
- 4. The Director of Medical Education is directed to take necessary action accordingly.
