ORDER:

The Director of Medical Education in his letter read above has stated that the Government Villupuram Medical College and Hospital, Villupuram is facing power breakdown issues for hours together and during such times, power supply is being managed with the help of generators involving extra expenditure towards fuel charges.

2. In order to ensure smooth functioning of costly life saving equipment and to reduce extra expenditure to Government, the Director of Medical Education has requested provision of a separate 22KV feeder HT line from Poothamedu 110/ 22KV sub-station under the railway line between Vikravandi and Mundiampakkam railway stations to provide dual connection to the existing HT Sc.80 of the Government Villupuram Medical College and Hospital, Villupuram for uninterrupted power supply to overcome power breakdown and voltage fluctuation problem and requested administrative and financial sanction of a sum of Rs.2,04,94,350/-, based on the estimate received from the TANGEDCO.

3. The Government after careful examination, accept the proposal of the Director of Medical Education and accord administrative and financial sanction for Rs.2,04,94,350/- (Rupees Two Crore Four Lakh Ninety Four Thousand Three Hundred and Fifty only) for providing a separate 22KV feeder HT line from Poothamedu 110/22KV substation under the railway line between Vikravandi and Mundiampakkam railway stations (Dual connection) by providing separate connection to the existing service line HTSc.80 of the Government Villupuram Medical College and Hospital, Villupuram District for smooth functioning.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

5. Necessary additional funds of Rs.2,04,95,000/- will be provided in RE / FMA 2022-23. Pending provision of such funds, the Director of Medical Education is authorized to draw and disburse the sanctioned amount in para 3 above. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion in the Supplementary Estimate 2022-23. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for RE / FMA 2022-23 and also send draft explanatory notes for specific inclusion in the Supplementary Estimate 2022-23 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
