ORDER:

Based on the request of the Director General, Employees' State Insurance Corporation, New Delhi in the letter 1st read above, the Government in the letter 2nd read above, have conveyed the 'in-principle' consent for taking over the Employees' State Insurance Corporation Medical College and Hospital at Singanallur, Coimbatore.

- 2. The Government, after considering the growing demand of meritorious students of the State for Professional Medical Courses, have decided to start a new Government Medical College in Singanallur, Coimbatore by taking over the Employees' State Insurance Corporation Medical College and Hospital from the academic year 2016-2017.
 - 3. The Government accordingly issue the following orders:
 - i. a new Government Medical College and Employees' State Insurance Corporation Hospital with an annual intake of 100 MBBS students from the academic year 2016-2017 will be established at Singanallur, Coimbatore by taking over the ESIC Medical College and Hospital at Singanallur, Coimbatore.

ii. Sanction is accorded for creation of one post of Dean-cum-Special Officer in the scale of pay of Rs.37400 – 67000 + G.P.8800/- with the following supporting staff for pursuing further administrative activities of the new Medical College and for obtaining Letter of Intent and the Letter of Permission from the Government of India.

The financial commitment for the posts is Rs.38,36,000/- (Rupees Thirty eight lakhs and thirty six thousands only) per annum. The holders of the above posts are eligible to draw Dearness Allowance, House Rent Allowance and other allowances applicable as per rules.

- iii. orders in respect of land, building, hospital equipments, furniture and staff, etc. will be issued separately as per Medical Council of India norms.
- 4. The expenditure in respect of the posts sanctioned in para 3(ii) above shall be debited under the following New Head of Account opened under Demand No.19-03

"2210 Medical and Public Health 05 – Medical Education, Training and Research 105 Allopathy – I Non-Plan CC - Government Medical College and ESIC Hospital, Coimbatore 01 – Salaries.

- 5. The Director of Medical Education is the estimating, reconciling and controlling authority for the above said new Head of Account.
- 6. The Pay and Accounts Officer / Treasury Officer is directed to open the above new Head of Account in their books.
- 7. The expenditure sanctioned in para 3 (ii) above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the

Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2015-2016 to Finance Department at the appropriate time without fail.
