ORDER :

In the order first read above administrative sanction was accorded for the implementation of Tamil Nadu Urban Health Care Project at a cost of Rs.16,34,69,50,000/- with the assistance of Japanese International Cooperation Agency (JICA). The Project Director, Tamil Nadu Urban Health Care Project was permitted to establish Tamil Nadu Urban Health Care Society to implement the Tamil Nadu Urban Health Care Project in Tamil Nadu in 21 Urban Towns / Cities in 17 Districts of the State.

2. In the Government Order second read above, sanction was accorded for creation of a Project Management Unit for Tamil Nadu Urban Health Care Project comprising, of five cells with the composition of staff.

3. The Project Director, Tamil Nadu Urban Health Care Project has stated that the Project Management Unit is functioning in a part of the premises occupied by erstwhile Tamil Nadu Health Systems Project in the Directorate of Medical Service Annex Building. The project has taken over the office rooms in the ground floor, I, III and IV floors of the building. In many of the rooms the furniture are not available and the available ones are in a state of repair. The Project Director, Tamil Nadu Urban Health Care Project has proposed that an amount of Rs.10.00 lakh may be sanctioned for the procurement of furniture to equip the rooms meant for the International and National experts. The furniture will be purchased from M/s Tamil Nadu Small Industries Corporation Limited. The expenditure can be met out from Tamil Nadu Urban Health Care Project society funds and booked under the administrative cost of the project under overall project cost.

4. The Government after careful consideration of the proposal of Project Director, Tamil Nadu Urban Health Care Project has decided to accept the proposal. Accordingly, sanction is accorded for a sum of Rs.10 lakh from the Administrative cost of the Tamil Nadu Urban Health Care society funds (TNUHCS) for procurement of furniture to the Office of the Tamil Nadu Urban Health Care Project (TNUHCP).

5. This order issues with concurrence of Finance Department vide its U.O.No.52000/H II/ 2017, dated 7.12.2017.
