ORDER:

In the Government Order first read above, the Government have accorded administrative and financial sanction for a sum of Rs.4,97,00,000/- for the construction of Academic Block and Hostel Building for the School of Nursing in the Government Medical College Hospital Campus at Chengalpattu.

2. The Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai has stated that the revised estimate works out at Rs.5,17,39,854/due to tender excess, the details of which are as follows:-

The Director of Medical Education has stated that the revised estimate is due to tender excess and as no provisional amount has been made in the sanctioned estimate to meet out the excess in the tender value, the excess amount can only be met out from additional sanction. Hence, she has requested revised administrative sanction for a sum of Rs.5,17,39,854/- against the original sanction of Rs. 4,97,00,000/-. She has countersigned and forwarded the revised estimate prepared by Engineer-in-Chief and Chief Engineer (Buildings), Chennai Region and Chief Engineer (General), Public Works Department, Chennai.
- 4. The proposal has been cleared by Technical Advisory Committee constituted in G.O.(Ms) No.146, Public Works Department, dated 12.08.2011 to scrutinize the revised administrative sanction proposal in respect of all technical and financial aspects involved in the work and the Tender Award Committee in its 188th meeting on 06.09.2013, has approved the revised administrative sanction proposal for a sum of Rs.5,17,39,854/- for the construction of Academic Block and Hostel Building for the School of Nursing in the Government Medical College Hospital Campus at Chengalpattu, with an instruction that there should not be any further revised administrative sanction and subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Chennai.
- 5. The Government have examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, revised administrative sanction is accorded for a sum of Rs.5,17,39,854/-(Rupees Five Crore Seventeen Lakhs Thirty Nine Thousand Eight Hundred and Fifty Four only) towards the construction of Academic Block and Hostel Building for the School of Nursing in the Government Medical College Hospital Campus at Chengalpattu as against the original sanction of Rs. 4,97,00,000/-.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-
 - "4210-Capital Outlay on Medical and Public Health-01 Urban Health Services 110 Hospitals and Dispensaries (Including Pharmacy) Schemes in the Twelfth Five Year Plan II State Plan JA Buildings -16 Major Works" (DPC 4210-01-110-JA -1602)
- 7. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2014-2015. Pending provision of such funds, the Chief Engineer (Buildings) authorised to draw and utilize the amount sanctioned in para 5 above. However this expenditure will be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2014-2015. The Chief Engineer (Buildings), Chennai is directed to include this item of expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2014-2015 and send necessary drafts explanatory notes for inclusion of the expenditure in the Supplementary Estimate to the Government in Finance Department without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.68324/Health-II/2014, dated 18.12.2014 and ASL No. 1776 (One Thousand Seven Hundred and Seventy Six).
