#### ORDER:

In G.O. (D) No.381, Health and Family Welfare Department, dated 21.04.2011, orders have been issued for sanction of further continuance of 485 temporary posts instead of 495 temporary posts attached to National Leprosy Eradication Programme for the period from 01.07.2010 to 31.03.2013. Out of 495 temporary posts, 10 temporary posts has been redeployed to the Tamil Nadu Health System Project and these posts have been excluded from the proposal of the Director of Medical and Rural Health Services (495 - 10 = 485 temporary posts). Hence, the Director of Medical and Rural Health Services has requested to send proposal to Government for further continuance for the above 10 temporary posts for the period from 01.07.2010 to 31.03.2012. The Director of Medical and Rural Health Services, has submitted further continuance

proposal for the remaining 10 temporary posts attached to the Institutions and redeployed to Tamil Nadu Health System Project for the period from 01.07.2010 to 30.09.2013.

- 2. Sanction is accorded for further continuance of 10 temporary posts attached to the National Leprosy Eradication Programme and the Office of Director of Medical and Rural Health Services as detailed in the Annexure to this order for a further period from 01.07.2010 to 30.09.2013, or till the Government of India's funds for this scheme, whichever earlier.
- 3. The holders of the posts are eligible to draw pay and order allowances admissible under the rules in force and orders issued from time to time.
