ORDER:

During the Budget session for the year 2014-2015 Hon'ble Chief Minister has made the following announcement under Rule 110

“ The Government Hospitals such as 45 Medical and Dental College Hospitals, 30 District Head Quarters Hospital, 240 Taluk and Non-Taluk Hospitals with the total of 315 Government Hospitals will be provided with protected drinking water facilities by installing Reverse Osmosis (R.O) water plant for the patients and attendees to the cost of Rs. 40,00,00,000/-“.

2. Based on the announcement, the Director of Medical and Rural Health Services in the letter cited above, has stated that his Directorate being at the secondary level, is the basic unit of the Public Health Care System evolved in Tamil Nadu and it has a history of 92 years and entrusted with the responsibility of providing secondary level medical care to the public through the hospitals located throughout the Urban, Semi Urban and landscape of the state (viz),

❖ Taluk Hospitals	:	160

He has also added that in addition of providing quality secondary care of the aforesaid hospital, it also extended the medical specialty services such as Surgery, Venerology, ENT, Medicine, Ophthalmology, Orthopaedics, Anaesthesiology, Child Health,

CEmONC, NBSC, SNCU, Dental, Psychiatry, Laboratory Services, Leprosy, Dialectology, Cardiology, NCD, 24 hours Trauma Care etc., and all the Government Hospitals have been provided with additional infrastructure inclusively of extended OP Block, Patient Waiting Room, etc., under National Rural Health Mission and Tamil Nadu Health System Project funds.

3. The Director of Medical and Rural Health Services has justified that the Reverse Osmosis is a technical water purification which removes many types of micro-organisms from salts water and also more economical operation in the matter and this also facilitated to avoid the hardship to the patients and to their attendees and requested the average cost of expenditure of Rs.14,79,60,000/- (Rupees Fourteen Crores Seventy Nine Lakhs and Sixty Thousand only) towards the provision of protected drinking water by installing reverse Osmosis technology to Government Hospitals under his Directorate as follows:-

The Government have examined the proposal of the Director of Medical and Rural Health Services in detail and accord permission to utilize a sum of Rs.14,79,60,000/- (Rupees Fourteen Crores Seventy Nine Lakhs and Sixty Thousand only) from out of the funds under the Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) (by making pro-rata deductions from the revenue earning hospitals) to the following institutions under his Directorate towards the provision of protected drinking water by installing Reverse Osmosis(R.O) water plant:-
