ORDER:

The Director of Drugs Control (i/c) has stated that the revised proforma invoice has been received from the ELCOT towards cost of Broad Band Internet Connection which has been revised from Rs. 1,03,084 to Rs. 1,11,519 based on the increasing the new rate contract tender for the basic cost of broad band connectivity from Rs. 5500/- to Rs. 6050/-.

- 2. The Director of Drugs Control (i/c) has also stated that a sum of Rs. 74,000/-has been provided in BE 2013 14 and requested an additional amount of Rs. 80,000/-towards the Revised ELCOT bill (for Rs. 45,000/-) and the expenses to be incurred to AMC and other charges for the period from December 2013 to March 2014 (for Rs. 35,000/-).
- 3. The Government have carefully examined the proposal of the Director of Drugs Control (i/c) at para 2 above and have decided to accept the same. Accordingly, the Government accord sanction for a sum of Rs. 80,000/- (Rupees eighty thousand only) towards the revised ELCOT bill and other charges for the period from December 2013 to March 2014.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

"2210 – Medical and Public Health – 06 Public Health – 104 Drug Control – I – Non Plan – AA- Administration of the Drugs Act 1940 – 76 – Computers and Accessories – 02 – Maintenance." (D.P.C 2210 - 06 - 104 - AA - 7625).

- 5. Necessary funds for the expenditure sanctioned in para 3 above will be provided in Revised Estimate / Final Modified appropriation 2014-15. Pending provision of funds in Revised Estimate / Final Modified Appropriation 2014 2015, the Director of Drugs Control (i/c) is authorised to draw and disburse the expenditure sanctioned in para 3 above. The Director of Drugs Control is instructed to include this item of expenditure while sending proposals for Revised Estimate / Final Modified Appropriation 2014-15 to Finance Department without fail. He is also directed to submit the Utilization Certificate and Statement of Expenditure in this regard to Government at the end of every financial year.
- 6. This order issues with the concurrence of Finance Department vide its U.O. No. 19663/Health II/2014, dated 16.04.2014 vide Additional Sanction Ledger No. 168 (One hundred and sixty eight).
