ORDER:

In the letter read above, the Mission Director, National Health Mission has stated that the Government of India have transferred and credited its share into Government of Tamil Nadu account being the Grants-in-Aid for Flexible Pool for Communicable Diseases (NDCPs) for the year 2018-19 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs.8,00,000/- (Rupees Eight lakh only) works out of Rs.5,33,333/- (Rupees Five lakh thirty three thousand three hundred and thirty three only).

3. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.13,33,333/- (Rupees Thirteen lakh thirty three thousand three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme(NDCP) for the year 2018 - 2019 as mentioned above and to authorize

him to draw the above amount under National Health Mission through Treasury mode and credit into National Health Mission Account.

4. The Mission Director, National Health Mission has also requested the Government to re-appropriate a sum of Rs.13,33,333/- from the Head of Account 2211 00 103 UA 09 32(General) to 2211 00 794 UA 09 39 (STSP).

5. The Government after careful consideration has decided to accept the above proposal of the Mission Director, National Health Mission and accordingly order as follows:

- i. A sum of Rs.13,33,333/- (Rupees Thirteen lakh thirty three thousand three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme (NDCPs) for the year 2018 - 2019 be sanctioned to the Mission Director, National Health Mission.
- ii. A sum of Rs. 13,33,333/- (Rupees Thirteen lakh thirty three thousand three hundred and thirty three only) shall be re-appropriated from 2211 00 103 UA 09 03 Grants for Specific Schemes (General) to 2211 00 794 UA 09 03 Grants for Specific Schemes (STSP).

6. The amount sanctioned in para 5 above shall be debited to following heads of account:-

Necessary funds will be provided in the RE/FMA 2018-19, Pending provision of such funds in RE/FMA 2018-19, by way of re-appropriation from the Head of Account "2211 00 103 UA 09 03" the Mission Director, State Health Society / Project Director, Reproductive & Child Health Project, Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 5 above. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2018-19. The Mission Director, State Health Society / Project Director, Reproductive & Child Health Project, Tamil Nadu is also requested to include this expenditure while sending the budget proposals for RE/FMA 2018-19 and draft Supplementary Estimates 2018-19 to Government in Finance (Health-I) Department without fail.

8. The Mission Director, State Health Society / Project Director, Reproductive and Child Health Project, Tamil Nadu is authorized to draw the amount sanctioned in para 5 above and to credit into State Health Society Account.
