#### **ORDER:**

In Government Order fourth read above, permission was accorded to Chairman, Srinivasan Health & Educational Trust, Perambalur to apply to the Pharmacy Council of India, New Delhi to start 4 years B.Pharm course at Srinivasan College of Pharmaceutical Sciences, Samayapuram, Trichy with an annual intake of 60 students from the academic year 2017-2018, subject to the usual conditions before admitting the students.

2. In its Government letter fifth read above, the Director of Medical Education was requested to re-submit the proposal for permission to start B.Pharm course with all required documents before admission of students for the year 2017-2018 after obtaining the approval of the Pharmacy Council of India, New Delhi.

- 3. The Principal, Srinivasan College of Pharmaceutical Sciences, Samayapuram, Trichy run by Srinivasan Health and Educational Trust, Perambalur has stated that they have got approval to conduct B.Pharm course with an annual intake of 60 seats from the academic year 2019-2020 and requested the Government to grant permission to start four years B.Pharm course with an annual intake of 60 students at "Srinivasan College of Pharmaceutical Sciences, Samayapuram, Tiruchirappalli" from the academic year 2019-2020.
- 4. In his letter sixth read above, the Director of Medical Education has stated that the DTCP approval has been issued from the Deputy Director, Director of Town and Country Planning, Trichirapalli zone for Srinivasan College of Pharmaceutical Sciences, Samayapuram, Trichirapalli in proceeding No.1785/2014/身山2, dated: 23.02.2015. The Pharmacy Council of India has also granted approval for conduct of Diploma and Degree courses for the year 2019-2020 to the above College. He has requested the Government to issue necessary orders for starting the B.Pharm course at Srinivasan College of Pharmaceuticals Sciences, Samayapuram, Trichy from the academic year 2019-2020.
- 5. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to start the four years B.Pharm course with annual intake of 60 (sixty) students from the academic year 2019-20 at Srinivasan College of Pharmaceutical Sciences in S.F.No.104/1D, 114/1A, 1B, 1C. 1D, 4, 5, 6, 7, 9, 10, 115/8, 9, 237/14A, 14B, Samayapuram Village and Panchyat, Trichy run by Srinivasan Health and Educational Trust, Perambalur, subject to the following conditions:
  - a) Admission of students shall be made as per the rules fixed by the Government from time to time;
  - b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said pharmacy college.
  - c) The Government have the right to utilize the Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc;
  - d) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on re-inspection of the centres.

- e) The Trust should obtain the Clearance Certificate from State Pollution Control Board before admitting the students.
- f) The Trust should obtain the building completion certificate from the competent authority for the proposed Pharmacy College and submit to the Government before admitting the students.
- 6. The Director of Medical Education is directed to take necessary further action accordingly.
